LB174 amends civil procedure to change the statute of limitations on certain civil actions for sexual assault of a child. The bill amends to state that, except as otherwise provided in the State Tort Claims Act and the Political Subdivisions Tort Claims Act, there shall not be any time limitation for an action against an individual or individuals directly causing an injury or injuries suffered by a plaintiff when the plaintiff was a victim of the violation in section 28-319.01 or 28-320.01.

Expenditures:

The Supreme Court states that there is potential for the number of civil actions to increase due to the bill but the impact on judicial workload is unknown at this time. The agency will have a minimal fiscal impact to provide judicial education.
