- 2) Misconduct of the jury, prosecuting attorney, or witnesses.
- 3) Accident or surprise which ordinary prudence could not have guarded against.
- 4) Verdict was not sustained by sufficient evidence or is contrary to law.
- 5) Newly discovered evidence material for the defendant which he or she could not with reasonable diligence have discovered or produced at the trial.
