LB 240 amends the Nebraska Juvenile Code to provide for modification of disposition orders or conditions of probation or supervision upon motion by the juvenile and repeal the original section.

The court may continue the dispositional portion of the hearing from time to time upon such terms and conditions as the court may prescribe, including an order of restitution of any stolen or damaged property, or an order requiring the juvenile to participate in restorative justice programs or community service programs, if such order is in the interest of the juvenile's reformation or rehabilitation.

When the juvenile has exhausted all levels of probation supervision and options for community- based services and section 43-251.01 has been satisfied, a motion for commitment to a youth rehabilitation and treatment center may be filed.

#### Expenditures:

The Supreme Court states that it will have to provide judicial education, this will have minimal fiscal impact but the amount is unknown at this time.
