LB274 amends state statutes to allow disabled veterans with disabled veteran plates, to park in designated handicapped parking spaces.

The Nebraska Department of Motor Vehicles (NDMV), Nebraska Department of Veterans Affairs (NDVA), and the Nebraska Military Department (NMD) has all indicated no fiscal impact from LB274.

There is no basis to disagree with the NDMV, NDVA, nor the NMD estimates of no fiscal impact.
