LB 364 changes provisions of statute related to elections.

Section 3 requires each election commissioner to execute a bond with penalties in the amount of \$10,000.

Section 19 provides legislative intent that the following county offices be elected:

- County attorney;
- Public defender;
- County sheriff;
- County treasurer;
- Clerk of the district court;
- Election commissioner;
- Register of deeds;
- County clerk;
- County assessor;
- County engineer; and,
- County surveyor

Section 20 requires that an election commissioner be elected in each county having a population of more than 400,000 inhabitants at the statewide general election in 2024 for a four-year term. Counties having a population of not less than 40,000 nor more than 400,000 inhabitants at the statewide general election in 2024 shall elect an election commissioner for a two-year term and, beginning in 2026, a four-year term.

The Secretary of State and the Nebraska Political Accountability and Disclosure Commission estimate no fiscal impact to the state. There is no basis to disagree with these estimates.

Lancaster County estimates no fiscal impact from the provisions of LB 364.

Douglas County estimates the need to replace the Chief Deputy Election Commissioner position with a full-time employee. Since the cost associated with the position is a current expense, replacement with a full-time employee will only carry the marginal difference made up of salary and benefits.
