Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 437 would change the renewal period for insurance producer agencies from an annual to biennial basis, with the licenses renewing in April of each odd-numbered year. The bill has an operative date of 4/30/24.

The Department of Insurance (DOI) currently has ten thousand two hundred eighty-five agency licenses with an annual fee of \$50 per agency. In odd-numbered years, the DOI would not be processing these renewals. This would result in a revenue loss in FY 2024-25 of (\$514.250) and would have a continued revenue loss in the odd-numbered years in future bienniums.

There is no basis to disagree with these estimates.
