Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 514 amends provisions of the Election Act.

Section 5 provides a definition for "Electioneering" under the Election Act that means the deliberate, visible display or audible or physical dissemination of information for the purpose of advocating for or against any candidate, elected officeholder, political party, or ballot measure.

Section 6 prohibits any person from electioneering within fifty feet of any voter registration site.

Provisions of LB 514 also address the name by which a candidate shall be listed on a candidate filing form and legal name changes of candidates.

Section 15 requires that all signed petitions to place a person's name on the primary election ballot for President of the United States not filed with the Secretary of State shall become invalid if not filed by August 1 of the presidential election year.

Section 17 requires that all signed petitions for nomination for partisan and nonpartisan offices not filed with the Secretary of State by September 1 of the general election year shall become invalid.

Section 19 provides for a person to remove his or her name from a petition.

Section 23 allows a person who becomes a naturalized citizen of the United States after the voter registration deadline to register to vote by completing the necessary voter registration application no later than noon of the day before the election.

The Secretary of State and the Nebraska Political Accountability Commission estimate no fiscal impact. There is no basis to disagree with these estimates.
