Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB547 establishes the Capitol Preservation, Restoration, and Enhancement Endowment Fund which shall consist of money transferred by the Legislature, bequests, donations, gifts, grants, and other monies received for the sole purpose of restoring, preserving, and enhancing the Capitol courtyards. Money in this fund will be held in trust, and invested by the state investment officer. The Office of the Capitol Commission shall direct the State Treasurer to transfer money from the Capitol Preservation, Restoration, and Enhancement Endowment Fund to the Capitol Restoration Cash Fund, specifically for the purposes listed above. The money transferred out of the Capitol Preservation, Restoration, and Enhancement Endowment Fund each year, should not exceed 4% of the fund balance as it exists on January 1<sup>st</sup>, of each off-numbered year.

Both the Nebraska State Treasurer and the Department of Administrative Services – Office of the Capitol Commission have indicated no expected fiscal impact from LB547.

These estimations of no fiscal impact appear reasonable.
