LB 59 requires the State Court Administrator, the Attorney General, and the Supreme Court to electronically file a report to the Legislature's Judiciary Committee concerning the use of property taxes, income taxes, and sales taxes in paying for operations of the judicial system. Such report shall be submitted on or before January 1, 2025 and include any suggestions for reducing the use of such taxes and proposals for any legislation necessary to make such reductions.

The Attorney General estimates no fiscal impact. This appears to be reasonable.

The Supreme Court has not had sufficient time to reply to this request. However, it is likely that the cost of producing and submitting such a report will have minimal, if any, impact. When the Supreme Court's reply is received, this fiscal note will be updated.
