Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 628 changes the definition of "Certificate of Registration" in 21-102 to include verification that all members, managers, professional employees, and agents who are required to do so are duly licensed or otherwise legally authorized to render the professional service for which a limited liability company is organized.

The definition of "Professional service" in 21-102 is amended to mean any personal service rendered by an attorney, certified public accountant, public accountant, dentist, osteopathic physician, physician and surgeon, real estate broker, associated real estate broker, real estate salesperson, or veterinarian.

Section 2 allows any limited liability company, prior to the effective date of this act, to continue rendering professional services if the certificate of registration is maintained continuously on and after the effective date of this act.

The Secretary of State estimates that LB 628 will have no fiscal impact. There is a possibility that some revenue will be affected, but that amount is not anticipated to be significant.

There is no basis to disagree with this estimate.
