LB 737 amends the Nebraska Political Accountability and Disclosure Act.

Under the bill's provisions no person shall make one or more contributions to a candidate committee totaling more than one thousand dollars during an election period. Candidate committees shall refund any contribution from a person which exceed one thousand dollars.

The Nebraska Political Accountability and Disclosure Commission estimates a cost of \$12,700 to modify and reprint certain forms, modify the electronic filing system, and notify and educate filers and contributors. This estimate appears to be reasonable.
