The Nebraska Teacher Apprenticeship Program is to help recruit & increase teachers throughout Nebraska by utilizing an apprenticeship model for training. The Nebraska Department of Education (NDE) can work with higher education institutions, the Nebraska Department of Labor, & other State Departments of Education to implement the program. NDE can also use a pilot program to assist with the creation of the program.

The Nebraska Teacher Apprenticeship Fund will consist of money transferred by the Legislature & any gifts, grants, bequests, donations, or other contributions from public or private sources.

EXPENDITURES:

There is intent stated to transfer a yet to be determined amount from the General Fund for FY2023-24 to carry out the provisions of the fund.
