Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 7 provides a statute of limitations for exposure to hazardous or toxic chemicals. It would amend section 25-224. The bill seeks to provide for statute of limitations of ten years for actions based upon exposure to hazardous or toxic chemicals to collect damages. A victim can recover damages earlier if informed by a competent medical authority that exposure to hazardous chemicals lead to injury or death or if parties reasonably knew chemicals would cause harm despite their use. This bill would provide extended time to those impacted by hazardous chemicals to understand the full extent of their damages.

The Supreme Court state that there could be a minimal fiscal impact for judicial education. Judicial and court workload not estimated to increase significantly and no additional resources required.
