LB 985 amends the Nebraska Teacher Recruitment and Retention Act (Act), section 79-8,114.

LB 985 updates provisions to expand eligibility to include contracts submitted prior to effective date of the Act to complete a school year of full-time employment as a teacher at a Nebraska school in school year 2024-25, 2025-26, or 2026-27.

LB 985 adds language for an application submitted on or after the effective date of the Act, signs a contract to complete a school year of full-time employment as a teacher to teach in such endorsement area at a Nebraska school in school year 2024-25, 2025-26, or 2026-27.

This Act is administered by the State Board of Education, Ne. Rev. Stat. § 79-8,113.

The bill contains an emergency clause and becomes law upon enactment.

It is estimated that LB 985 will have no impact on General Fund revenue.

It is estimated that there will be no cost to the Department of Revenue to implement this bill.
