A BILL FOR AN ACT relating to retirement; to amend sections 4-108, 4-111, 1 2 4-112, 23-2306, 24-703.01, 60-1304, 79-955, 79-9,118, 81-2016, 84-1503.03, and 84-1504, Reissue Revised Statutes of Nebraska, 3 sections 79-901, 79-915, 79-978, 79-992, 79-9,117, 81-1316, 84-1307, 4 5 and 84-1501, Revised Statutes Cumulative Supplement, 2022, and sections 79-902 and 79-920, Revised Statutes Supplement, 2023; to 6 7 change provisions relating to participation in retirement programs 8 by noncitizens; to change provisions relating to returning to work after termination and contributions under the School Employees 9 10 Retirement Act and the Class V School Employees Retirement Act; to define and redefine terms; to change provisions relating to the 11 preretirement planning program, the State Personnel System, and the 12 members of the Public Employees Retirement Board; to provide for the 13 14 hiring of assistant directors and deputies of the Nebraska Public Employees Retirement Systems and to authorize compensation for such 15 employees to be determined by the director; to eliminate obsolete 16 17 provisions; to harmonize provisions; to repeal the original 18 sections; and to declare an emergency.

1 Section 1. Section 4-108, Reissue Revised Statutes of Nebraska, is

- 15 process, any governmental entity currently participating in the

- 19 soon as reasonably practicable, but no later than one hundred eighty days
- 20 before the transaction is to occur.
- 21 (ii) The board when timely notified shall, as soon as is reasonably
- 22 practicable, obtain from its contracted actuary the cost of any actuarial
- 23 study necessary to determine the potential funding obligation. The board
- 24 shall notify the entity of such cost.
- 25 (iii) If such entity pays the board's contracted actuary pursuant to
- 26 subdivision (4)(c)(vi) of this section for any actuarial study necessary
- 27 to determine the potential funding obligation, the board shall, as soon
- 28 as reasonably practicable following its receipt of the actuarial study,

- 1 (i) Business transaction means a merger; consolidation; sale of 2 assets, equipment, or facilities; termination of a division, department, 3 section, or subgroup of the entity; or any other business transaction that results in termination of some or all of the entity's workforce; and 4 5 Funding obligation means the financial liability of the retirement system to provide benefits for the affected plan members 6 7 incurred by the retirement system due to the entity's business transaction calculated using the methodology and assumptions recommended 8 9 by the board's contracted actuary and approved by the board. The methodology and assumptions used must be structured in a way that ensures 10 the entity is financially liable for all the costs of the entity's 11 business transaction, and the retirement system is not financially liable 12 13 for any of the cost of the entity's business transaction.
- (e) The board may adopt and promulgate rules and regulations to carry out this subsection including, but not limited to, the methods of notifying the board of pending business transactions, the acceptable methods of payment, and the timing of such payment.
- (5) Within the first one hundred eighty days of employment, a full-18 time employee may apply to the board for vesting credit for years of 19 participation in another Nebraska governmental plan, as defined by 20 section 414(d) of the Internal Revenue Code. During the years of 21 participation in the other Nebraska governmental plan, the employee must 22 23 have been a full-time employee, as defined in the Nebraska governmental 24 plan in which the credit was earned. The board may adopt and promulgate rules and regulations governing the assessment and granting of vesting 25 credit. 26
- 27 (6) Any employee who qualifies for membership in the retirement 28 system pursuant to this section may not be disqualified from membership 29 in the retirement system solely because such employee also maintains 30 separate employment which qualifies the employee for membership in 31 another public retirement system, nor may membership in this retirement

- 1 system disqualify such an employee from membership in another public
- 2 retirement system solely by reason of separate employment which qualifies
- 3 such employee for membership in this retirement system.

If the AAA-rated segment of the Bloomberg Barclays Long U.S. Corporate Bond Index is discontinued or replaced, a substitute index shall be selected by the board which shall be a reasonably representative index;
