- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 388, One Hundred
- 3 Eighth Legislature, Second Session, 2024; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. The State Treasurer shall transfer an amount equal to
- 2 the difference between \$750,000,000 and the amount transferred to the
- 3 School Property Tax Credit Fund pursuant to section 77-4602, if the
- 4 difference is a positive number, from the General Fund to the School
- 5 Property Tax Credit Fund on or before December 31, 2024, on such dates
- 6 and in such amounts as directed by the budget administrator of the budget
- 7 division of the Department of Administrative Services.
- 8 Sec. 2. There is hereby appropriated (1) \$757,581 from the General
- 9 Fund for FY2024-25 and (2) \$235,832 from the General Fund for FY2025-26
- 10 to the Department of Revenue, for Program 102, to aid in carrying out the
- 11 provisions of Legislative Bill 388, One Hundred Eighth Legislature,
- 12 Second Session, 2024.
- 13 <u>Total expenditures for permanent and temporary salaries and per</u>
- 14 diems from funds appropriated in this section shall not exceed \$98,900
- 15 for FY2024-25 or \$58,900 for FY2025-26.
- 16 Sec. 3. There is hereby appropriated (1) \$750,000,000 from the
- 17 School Property Tax Credit Fund for FY2024-25 and (2) \$780,000,000 from
- 18 the School Property Tax Credit Fund for FY2025-26 to the Department of
- 19 Revenue, for Program 121, to aid in carrying out the provisions of
- 20 Legislative Bill 388, One Hundred Eighth Legislature, Second Session,
- 21 2024.
- 22 There is included in the appropriation to this program for FY2024-25
- 23 \$750,000,000 Cash Funds for state aid, which shall only be used for such
- 24 purpose. There is included in the appropriation to this program for
- 25 FY2025-26 \$780,000,000 Cash Funds for state aid, which shall only be used
- for such purpose.
- 27 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 28 for state employees shall be made from funds appropriated in this
- 29 <u>section.</u>
- 30 Sec. 4. Since an emergency exists, this act takes effect when
- 31 passed and approved according to law.
