- 1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 727, One Hundred
- 3 Eighth Legislature, First Session, 2023; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. There is hereby appropriated (1) \$432,776 from the
- 2 General Fund for FY2023-24 and (2) \$158,320 from the General Fund for
- 3 FY2024-25 to the Department of Revenue, for Program 102, to aid in
- 4 carrying out the provisions of Legislative Bill 727, One Hundred Eighth
- 5 Legislature, First Session, 2023.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$136,900
- 8 for FY2023-24 or \$102,400 for FY2024-25.
- 9 Sec. 2. There is hereby appropriated (1) \$1,427,000 from the
- 10 Department of Transportation Aeronautics Capital Improvement Fund for
- 11 FY2023-24 and (2) \$1,648,000 from the Department of Transportation
- 12 <u>Aeronautics Capital Improvement Fund for FY2024-25 to the Department of</u>
- 13 Transportation, for Program 301, to aid in carrying out the provisions of
- 14 Legislative Bill 727, One Hundred Eighth Legislature, First Session,
- 15 2023.
- 16 There is included in the appropriation to this program for FY2023-24
- 17 \$1,427,000 Cash Funds for state aid, which shall only be used for such
- 18 purpose. There is included in the appropriation to this program for
- 19 FY2024-25 \$1,648,000 Cash Funds for state aid, which shall only be used
- for such purpose.
- 21 <u>No expenditures for permanent and temporary salaries and per diems</u>
- 22 for state employees shall be made from funds appropriated in this
- 23 section.
- 24 Sec. 3. There is hereby appropriated (1) \$128,220 from the General
- 25 Fund for FY2023-24 and (2) \$124,290 from the General Fund for FY2024-25
- 26 to the Department of Economic Development, for Program 603, to aid in
- 27 carrying out the provisions of Legislative Bill 727, One Hundred Eighth
- 28 Legislature, First Session, 2023.
- 29 <u>Total expenditures for permanent and temporary salaries and per</u>
- 30 diems from funds appropriated in this section shall not exceed \$68,750
- 31 for FY2023-24 or \$71,500 for FY2024-25.

1 Sec. 4. Since an emergency exists, this act takes effect when

2 passed and approved according to law.
