1 A BILL FOR AN ACT relating to gambling; to amend sections 2-1205, 9-204,
2 9-204.04, 9-601, 9-603, 9-606, 9-607, 9-646.01, 9-651, 9-1103,
3 9-1106, 9-1110, 81-3717, and 81-3720, Reissue Revised Statutes of
4 Nebraska; to change provisions relating to horseracing, the Nebraska
5 Bingo Act, the Nebraska County and City Lottery Act, the Nebraska
6 Racetrack Gaming Act, and the Nebraska Visitors Development Act; and
7 to repeal the original sections.
8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 2-1205, Reissue Revised Statutes of Nebraska, is
2 amended to read:

3 2-1205 (1) If the commission is satisfied that its rules and
4 regulations and all provisions of sections 2-1201 to 2-1218 have been and
5 will be complied with, it may issue a license for a period of not more
6 than five years. The license shall set forth the name of the licensee,
7 the place where the races or race meetings are to be held, and the time
8 and number of days during which racing may be conducted by such licensee.
9 Any such license issued shall not be transferable or assignable. The
10 commission shall have the power to revoke any license issued at any time
11 for good cause upon reasonable notice and hearing. No license shall be
12 granted to any corporation or association except upon the express
13 condition that it shall not, by any lease, contract, understanding, or
14 arrangement of whatever kind or nature, grant, assign, or turn over to
15 any person, corporation, or association the operation or management of
16 any racing or race meeting licensed under such sections or of the
17 parimutuel system of wagering described in section 2-1207 or in any
18 manner permit any person, corporation, or association other than the
19 licensee to have any share, percentage, or proportion of the money
20 received for admissions to the racing or race meeting or from the
21 operation of the parimutuel system; and any violation of such conditions
22 shall authorize and require the commission immediately to revoke such
23 license. No licensee shall be considered in violation of this section
24 with respect to an agreement with an authorized gaming operator regarding
25 employees and the acceptance of any parimutuel wager or sports wager
26 pursuant to section 9-1110.

27 (2)(a) Any racetrack for which a licensee is issued a license to
28 conduct a race or race meeting under sections 2-1201 to 2-1218 which is
29 in existence and operational as of April 20, 2022, shall:

30 (i) Hold a minimum of five live racing meet days and fifty live
31 horseraces annually beginning January 1, 2026, through December 31, 2030;

1 and

2 (ii) Beginning January 1, 2031, hold a minimum of fifteen live
3 racing meet days and one hundred twenty live horseraces annually.

4 (b) Any racetrack for which a licensee is issued a license to
5 conduct a race or race meeting under sections 2-1201 to 2-1218 which is
6 not in existence and operational until after April 20, 2022, shall:

7 (i) Hold a minimum of one live racing meet day annually for the
8 first three years of operation;

9 (ii) Hold a minimum of five live racing meet days and fifty live
10 horseraces annually for the fourth year of operation through the seventh
11 year of operation; and

12 (iii) Beginning with the eighth year of operation, hold a minimum of
13 fifteen live racing meet days and one hundred twenty live horseraces
14 annually.

15 (c) A racetrack that fails to meet the minimum requirements under
16 this subsection is subject to discipline by the commission, including
17 revocation of the license issued under sections 2-1201 to 2-1218.

18 (3) A racetrack for which a licensee is issued a license to conduct
19 a race or race meeting under sections 2-1201 to 2-1218 in existence on
20 November 1, 2020, which is located in the counties of Adams, Dakota,
21 Douglas, Hall, Lancaster, and Platte, may move such racetrack location to
22 another county in Nebraska that does not have a racetrack one time only,
23 subject to approval by the commission as provided in subdivision (27) of
24 section 9-1106, subsequent to the initial issuance of the market analysis
25 and socioeconomic-impact studies conducted pursuant to section 9-1106.

26 Sec. 2. Section 9-204, Reissue Revised Statutes of Nebraska, is
27 amended to read:

28 9-204 (1) Bingo shall mean that form of gambling in which:

29 (a) The winning numbers are determined by random selection from a
30 pool of seventy-five or ninety numbered designators; and

31 (b) A player marks ~~Players mark~~ by physically daubing or covering

1 or, automatically or manually with the aid of a bingo card monitoring
2 device, enters or otherwise conceals ~~concealing~~ those randomly selected
3 numbers which match on a bingo card that the player has ~~cards which they~~
4 ~~have~~ purchased or leased only at the time and place of the bingo
5 occasion.

6 (2) Bingo shall not mean or include:

7 (a) Any scheme which uses any mechanical gaming device, computer
8 gaming device, electronic gaming device, or video gaming device which has
9 the capability of awarding something of value, free games redeemable for
10 something of value, or tickets or stubs redeemable for something of
11 value;

12 (b) Any activity which is authorized or regulated under the Nebraska
13 County and City Lottery Act, the Nebraska Lottery and Raffle Act, the
14 Nebraska Pickle Card Lottery Act, the Nebraska Small Lottery and Raffle
15 Act, the State Lottery Act, section 9-701, or Chapter 2, article 12; or

16 (c) Any activity which is prohibited under Chapter 28, article 11.

17 Sec. 3. Section 9-204.04, Reissue Revised Statutes of Nebraska, is
18 amended to read:

19 9-204.04 Bingo card monitoring device shall mean a technological aid
20 which allows a bingo player to automatically or manually enter bingo
21 numbers as they are announced at a bingo occasion and which enters ~~marks~~
22 or otherwise conceals those numbers on bingo cards which are
23 electronically stored in and displayed on the device. A bingo card
24 monitoring device shall not mean or include any device (1) into which
25 currency, coins, or tokens may be inserted or from which currency, coins,
26 tokens, or any receipt for monetary value can be dispensed or (2) which,
27 once provided to a bingo player, is capable of communicating with any
28 other bingo card monitoring device or any other form of electronic device
29 or computer, except that such device may communicate with its host
30 system.

31 Sec. 4. Section 9-601, Reissue Revised Statutes of Nebraska, is

1 amended to read:

2 9-601 Sections 9-601 to 9-653 and sections 6 and 11 of this act
3 shall be known and may be cited as the Nebraska County and City Lottery
4 Act.

5 Sec. 5. Section 9-603, Reissue Revised Statutes of Nebraska, is
6 amended to read:

7 9-603 For purposes of the Nebraska County and City Lottery Act, the
8 definitions found in sections 9-603.02 to 9-618 and section 6 of this act
9 shall be used.

10 Sec. 6. Digital-on-premises ticket means a digital ticket purchased
11 in person on a mobile or other electronic device verified to be present
12 at the location of the lottery operator or an authorized sales outlet
13 location in accordance with subdivision (3)(b) of section 11 of this act.

14 Sec. 7. Section 9-606, Reissue Revised Statutes of Nebraska, is
15 amended to read:

16 9-606 Gross proceeds shall mean the total aggregate receipts
17 received from the conduct of any lottery conducted by any county, city,
18 or village without any reduction for prizes, discounts, taxes, or
19 expenses and shall include receipts from admission costs, any
20 consideration necessary for participation, and the value of any free
21 tickets, games, or plays used, except that gross proceeds shall not
22 include any admission costs collected at any location where the lottery
23 is also available to the public free of any admission charge.

24 Sec. 8. Section 9-607, Reissue Revised Statutes of Nebraska, is
25 amended to read:

26 9-607 (1) Lottery shall mean a gambling scheme in which:

27 (a) The players pay or agree to pay something of value for an
28 opportunity to win;

29 (b) Winning opportunities are represented by tickets;

30 (c) Winners are solely determined by one of the following two
31 methods:

1 (i) By a random drawing of tickets differentiated by sequential
2 enumeration from a receptacle by hand whereby each ticket has an equal
3 chance of being chosen in the drawing; or

4 (ii) By use of a game known as keno in which a player selects up to
5 twenty numbers from a total of eighty numbers on a ~~paper~~ ticket and a
6 computer, other electronic selection device, or electrically operated
7 blower machine which is not player-activated randomly selects up to
8 twenty numbers from the same pool of eighty numbers and the winning
9 players are determined by the correct matching of the numbers on the
10 ~~paper~~ ticket selected by the players with the numbers randomly selected
11 by the computer, other electronic selection device, or electrically
12 operated blower machine, except that (A) no keno game shall permit or
13 require player activation of lottery equipment and (B) the random
14 selection of numbers by the computer, other electronic selection device,
15 or electrically operated blower machine shall not occur within five
16 minutes of the completion of the previous selection of random numbers;
17 and

18 (d) The holders of the winning ~~paper~~ tickets are to receive cash or
19 prizes redeemable for cash. Selection of a winner or winners shall be
20 predicated solely on chance; and -

21 (e) Tickets are issued either (i) on paper or (ii) with the consent
22 of the governing body of the county, city, or village conducting the
23 lottery, digitally to a mobile or other device which, at the time of
24 purchase, is verified to be present at the location of the lottery
25 operator or an authorized sales outlet location as provided in
26 subdivision (3)(b) of section 11 of this act.

27 (2) Lottery shall not include:

28 (a) Any gambling scheme which uses any mechanical gaming device,
29 computer gaming device, electronic gaming device, or video gaming device
30 which has the capability of awarding something of value, free games
31 redeemable for something of value, or tickets or stubs redeemable for

1 something of value;

2 (b) Any activity authorized or regulated under the Nebraska Bingo
3 Act, the Nebraska Lottery and Raffle Act, the Nebraska Pickle Card
4 Lottery Act, the Nebraska Small Lottery and Raffle Act, the State Lottery
5 Act, section 9-701, or Chapter 2, article 12; or

6 (c) Any activity prohibited under Chapter 28, article 11.

7 (3) Notwithstanding the requirement in subdivision (1)(c)(ii) of
8 this section that a player select up to twenty numbers, a player may
9 select more than twenty numbers on a ~~paper~~ ticket when a top or bottom,
10 left or right, edge, or way ticket is played. For a top or bottom ticket,
11 the player shall select all numbers from one through forty or all numbers
12 from forty-one through eighty. For a left or right ticket, the player
13 shall select all numbers ending in one through five or all numbers ending
14 in six through zero. For an edge ticket, the player shall select all of
15 the numbers comprising the outside edge of the ticket. For a way ticket,
16 the player shall select a combination of groups of numbers in multiple
17 ways on a single ticket.

18 (4) A county, city, or village conducting a keno lottery shall
19 designate the method of winning number selection to be used in the
20 lottery and submit such designation in writing to the department prior to
21 conducting a keno lottery. Only those methods of winning number selection
22 described in subdivision (1)(c)(ii) of this section shall be permitted,
23 and the method of winning number selection initially utilized may only be
24 changed once during that business day as set forth in the designation. A
25 county, city, or village shall not change the method or methods of
26 winning number selection filed with the department or allow it to be
27 changed once such initial designation has been made unless (a) otherwise
28 authorized in writing by the department based upon a written request from
29 the county, city, or village or (b) an emergency arises in which case a
30 ball draw method of number selection would be switched to a number
31 selection by a random number generator. An emergency situation shall be

1 reported by the county, city, or village to the department within twenty-
2 four hours of its occurrence.

3 Sec. 9. Section 9-646.01, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 9-646.01 (1)(a) No person or licensee, or any employee or agent
6 thereof, accepting wagers on a lottery conducted pursuant to the Nebraska
7 County and City Lottery Act shall extend credit from the gross proceeds
8 of a lottery to participants in the lottery for the purchase of lottery
9 tickets. No person shall purchase or be allowed to purchase any lottery
10 ticket or make or be allowed to make any wager pursuant to the act unless
11 he or she pays for such ticket or wager with cash, a debit card, the cash
12 balance of a payment application, a transfer from a deposit account at a
13 financial institution, or an account established in the name of the
14 player with the lottery operator and funded as provided in subsection (2)
15 of this section. For purposes of this section, cash shall mean United
16 States currency having the same face value as the price of the ticket or
17 wager. A credit card shall not be accepted for payment for any wager on
18 keno.

19 (b) A participant shall not use a debit card to purchase more than
20 two hundred dollars of keno wagers from a lottery operator in a single
21 calendar day.

22 (2) A lottery operator may allow participants to create an account
23 to be used for lottery play. Such accounts may only be funded with cash,
24 a debit card, the cash balance of a payment application, or a transfer
25 from a deposit account at a financial institution. The lottery operator
26 may also allow a participant to deposit prize money won from the lottery
27 and refunds from the lottery into a lottery play account. A participant
28 shall not deposit funds into any such account from a debit card
29 transaction if the total amount of funds from all such debit card
30 transactions in that calendar day would exceed two hundred dollars.

31 Sec. 10. Section 9-651, Reissue Revised Statutes of Nebraska, is

1 amended to read:

2 9-651 Each county, city, or village conducting a lottery shall have
3 its name clearly associated with ~~printed on~~ each ticket used in the
4 lottery. No such ticket shall be sold unless such ~~the~~ name is clearly
5 identified ~~printed thereon~~.

6 Sec. 11. (1) Any purchase of a ticket for a keno game shall be made
7 in person at the location of the lottery operator or an authorized sales
8 outlet location.

9 (2) The lottery operator shall file with the department the address
10 of each location where digital-on-premises tickets are sold. The lottery
11 operator shall use reasonable safeguards approved by the department to
12 ensure that digital-on-premises tickets are only accessible to
13 individuals nineteen years of age or older.

14 (3) The lottery operator shall submit controls, for approval by the
15 department, that include the following at the location of the lottery
16 operator or the locations of its associated authorized sales outlets at
17 which digital-on-premises tickets are sold:

18 (a) Any specific procedure and any technology partner used to
19 fulfill the requirements set forth by the department;

20 (b) Any location detection procedure to reasonably detect and
21 dynamically monitor the location of a player attempting to purchase a
22 digital-on-premises ticket for a keno game. The location procedures shall
23 be designed so that a player outside the permitted boundary is rejected
24 and the player is notified. The permitted boundary shall be established
25 in such a manner that access is not regularly available away from the
26 property on which the licensed premises is situated and such boundary is
27 as closely matching to the actual or legal boundaries of the licensed
28 premises as reasonably possible;

29 (c) Any other specific controls as designated by the department;

30 (d) A process to prominently display and easily impose any
31 limitation parameters relating to the purchase of a digital-on-premises

1 ticket for a keno game; and

2 (e) An easy and obvious method for a player to make a complaint and
3 to enable the player to notify the department if such complaint has not
4 been or cannot be addressed by the lottery operator.

5 (4) The department shall approve or deny the controls within thirty
6 days after submission. If denied, the department shall provide the
7 reasons for denial and allow the lottery operator to resubmit revised
8 controls.

9 (5) The department may adopt and promulgate rules and regulations
10 relating to digital-on-premises tickets. Such rules and regulations shall
11 be adopted and promulgated no later than January 1, 2024.

12 Sec. 12. Section 9-1103, Reissue Revised Statutes of Nebraska, is
13 amended to read:

14 9-1103 For purposes of the Nebraska Racetrack Gaming Act:

15 (1) Authorized gaming operator means a person or entity licensed
16 pursuant to the act to operate games of chance within a licensed
17 racetrack enclosure;

18 (2) Authorized gaming operator license means a license to operate
19 games of chance as an authorized gaming operator at a licensed racetrack
20 enclosure;

21 (3)(a) Except as otherwise provided in subdivision (b) of this
22 subdivision, authorized sporting event means a professional sporting
23 event, a collegiate sporting event, an international sporting event, a
24 professional motor race event, a professional sports draft, an individual
25 sports award, an electronic sport, or a simulated game; and

26 (b) Authorized sporting event does not include an instate collegiate
27 sporting event in which an instate collegiate or university team is a
28 participant, a parimutuel wager, a fantasy sports contest, a minor league
29 sporting event, a sporting event at the high school level or below
30 regardless of the age of any individual participant, or any sporting
31 event excluded by the commission;

1 (4) Collegiate sporting event means an athletic event or competition
2 of an intercollegiate sport played at the collegiate level for which
3 eligibility requirements for participation by a student athlete are
4 established by a national association for the promotion or regulation of
5 collegiate athletics;

6 (5) Commission means the State Racing and Gaming Commission;

7 (6) Designated sports wagering area means an area, as approved by
8 the commission, in which sports wagering is conducted;

9 (7) Game of chance means any game which has the elements of chance,
10 prize, and consideration, including any wager on a slot machine, table
11 game, counter game, or card game, a keno lottery conducted in accordance
12 with the Nebraska County and City Lottery Act, or sports wagering. Game
13 of chance does not include any game the operation of which is prohibited
14 at a casino by federal law;

15 (8) Gaming device means an electronic, mechanical, or other device
16 which plays a game of chance when activated by a player using currency, a
17 token, or other item of value;

18 (9) International sporting event means an international team or
19 individual sporting event governed by an international sports federation
20 or sports governing body, including sporting events governed by the
21 International Olympic Committee and the International Federation of
22 Association Football;

23 (10) Licensed racetrack enclosure means all real property licensed
24 and utilized for the conduct of a race meeting, including the racetrack
25 and any grandstand, concession stand, office, barn, barn area, employee
26 housing facility, parking lot, and additional area designated by the
27 commission premises at which licensed live horseracing is conducted in
28 accordance with the Constitution of Nebraska and applicable Nebraska law;

29 (11) Limited gaming device means an electronic gaming device which
30 (a) offers games of chance, (b) does not dispense currency, tokens, or
31 other items of value, and (c) does not have a cash winnings hopper,

1 mechanical or simulated spinning reel, or side handle;

2 (12) Prohibited participant means any individual whose participation
3 may undermine the integrity of the wagering or the sporting event or any
4 person who is prohibited from sports wagering for other good cause shown
5 as determined by the commission, including, but not limited to: (a) Any
6 individual placing a wager as an agent or proxy; (b) any person who is an
7 athlete, a coach, a referee, or a player in any sporting event overseen
8 by the sports governing body of such person based on publicly available
9 information; (c) a person who holds a paid position of authority or
10 influence sufficient to exert influence over the participants in a
11 sporting event, including, but not limited to, any coach, manager,
12 handler, or athletic trainer, or a person with access to certain types of
13 exclusive information, on any sporting event overseen by the sports
14 governing body of such person based on publicly available information; or
15 (d) a person identified as prohibited from sports wagering by any list
16 provided by a sports governing body to the commission;

17 (13) Racing license means a license issued for a licensed racetrack
18 enclosure by the commission; and

19 (14) Sports wagering means the acceptance of wagers on an authorized
20 sporting event by any system of wagering as authorized by the commission.
21 Sports wagering does not include (a) placing a wager on the performance
22 or nonperformance of any individual athlete participating in a single
23 game or match of a collegiate sporting event in which a collegiate team
24 from this state is participating, (b) placing an in-game wager on any
25 game or match of a collegiate sporting event in which a collegiate team
26 from this state is participating, (c) placing a wager on the performance
27 or nonperformance of any individual athlete under eighteen years of age
28 participating in a professional or international sporting event, or (d)
29 placing a wager on the performance of athletes in an individual sporting
30 event excluded by the commission.

31 Sec. 13. Section 9-1106, Reissue Revised Statutes of Nebraska, is

1 amended to read:

2 9-1106 The commission shall:

3 (1) License and regulate authorized gaming operators for the
4 operation of all games of chance authorized pursuant to the Nebraska
5 Racetrack Gaming Act, including adopting, promulgating, and enforcing
6 rules and regulations governing such authorized gaming operators
7 consistent with the act;

8 (2) Regulate the operation of games of chance in order to prevent
9 and eliminate corrupt practices and fraudulent behavior, and thereby
10 promote integrity, security, and honest administration in, and accurate
11 accounting of, the operation of games of chance which are subject to the
12 act;

13 (3) Establish criteria to license applicants for authorized gaming
14 operator licenses and all other types of gaming licenses for other
15 positions and functions incident to the operation of games of chance,
16 including adopting, promulgating, and enforcing rules, regulations, and
17 eligibility standards for such authorized gaming operator licenses,
18 gaming licenses, and positions and functions incident to the operation of
19 games of chance;

20 (4) Charge fees for applications for licenses and for the issuance
21 of authorized gaming operator licenses and all other types of gaming
22 licenses to successful applicants which shall be payable to the
23 commission;

24 (5) Charge fees to authorized gaming operators in an amount
25 necessary to offset the cost of oversight and regulatory services to be
26 provided which shall be payable to the commission;

27 (6) Impose a one-time authorized gaming operator license fee of five
28 million dollars on each authorized gaming operator for each licensed
29 racetrack enclosure payable to the commission. The license fee may be
30 paid over a period of five years with one million dollars due at the time
31 the license is issued;

1 (7) Grant, deny, revoke, and suspend authorized gaming operator
2 licenses and all other types of gaming licenses based upon reasonable
3 criteria and procedures established by the commission to facilitate the
4 integrity, productivity, and lawful conduct of gaming within the state;

5 (8) Grant or deny for cause applications for authorized gaming
6 operator licenses of not less than twenty years in duration, subject to
7 an annual review by the commission and receipt by the commission of a
8 fifty-thousand-dollar annual review fee, with no more than one such
9 authorized gaming operator license granted for any licensed racetrack
10 enclosure within the state;

11 (9) Conduct background investigations of applicants for authorized
12 gaming operator licenses and all other types of gaming licenses;

13 (10) Adopt and promulgate rules and regulations for the standards of
14 manufacture of gaming equipment;

15 (11) Inspect the operation of any authorized gaming operator
16 conducting games of chance for the purpose of certifying the revenue
17 thereof and receiving complaints from the public;

18 (12) Issue subpoenas for the attendance of witnesses or the
19 production of any records, books, memoranda, documents, or other papers
20 or things at or prior to any hearing as is necessary to enable the
21 commission to effectively discharge its duties;

22 (13) Administer oaths or affirmations as necessary to carry out the
23 act;

24 (14) Have the authority to impose, subject to judicial review,
25 appropriate administrative fines and penalties for each violation of the
26 act or any rules and regulations adopted and promulgated pursuant to the
27 act in an amount not to exceed:

28 (a) For any licensed racetrack enclosure with an authorized gaming
29 operator operating games of chance for one year or less, fifty thousand
30 dollars per violation; or

31 (b) For any licensed racetrack enclosure with an authorized gaming

1 operator operating games of chance for more than one year, three times
2 the highest daily amount of gross receipts derived from wagering on games
3 of chance during the twelve months preceding the violation at such
4 licensed racetrack enclosure gaming facility per violation;

5 (15) Collect and remit administrative fines and penalties collected
6 under this section to the State Treasurer for distribution in accordance
7 with Article VII, section 5, of the Constitution of Nebraska;

8 (16) Adopt and promulgate rules and regulations for any gaming taxes
9 assessed to authorized gaming operators;

10 (17) Collect and account for any gaming taxes assessed to authorized
11 gaming operators and remit such taxes to the State Treasurer or county
12 treasurer as required by Nebraska law;

13 (18) Promote treatment of gaming-related behavioral disorders;

14 (19) Establish procedures for the governance of the commission;

15 (20) Acquire necessary offices, facilities, counsel, and staff;

16 (21) Establish procedures for an applicant for a staff position to
17 disclose conflicts of interest as part of the application for employment;

18 (22) Establish a process to allow a person to be voluntarily
19 excluded from wagering in any game of chance under the act in accordance
20 with section 9-1118;

21 (23) Remit all license and application fees collected under the
22 Nebraska Racetrack Gaming Act to the State Treasurer for credit to the
23 Racing and Gaming Commission's Racetrack Gaming Fund;

24 (24) Conduct or cause to be conducted a statewide horseracing market
25 analysis to study the racing market as it currently exists across the
26 state and within the locations in Nebraska of the racetracks in Adams,
27 Dakota, Douglas, Hall, Lancaster, and Platte counties as of the date of
28 the market analysis. Such market analysis shall be completed as soon as
29 practicable but not later than January 1, 2025, and every five years
30 thereafter and shall be submitted electronically to the General Affairs
31 Committee of the Legislature and to the Governor. Such market analysis

1 shall examine the market potential and make recommendations involving:

2 (a) The number of live racing days per track, number of races run,
3 and number of horses that should be entered per race;

4 (b) The number of Nebraska-bred horses available in the market for
5 running races, including foals dropped in the state for the past three
6 years at the time of the market analysis;

7 (c) The circuit scheduled in the state and if any overlapping dates
8 would be beneficial to the circuit and market as a whole;

9 (d) The total number of horses available for the total annual
10 schedule, with separate analysis for thoroughbred races and quarterhorse
11 races;
