- 4 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
- 5 Session, 2023.
- 6 Total expenditures for permanent and temporary salaries and per
- 7 diems from funds appropriated in this section shall not exceed \$97,229
- 8 for FY2023-24 or \$186,402 for FY2024-25.
- 9 Sec. 2. There is hereby appropriated (1) \$83,221 from the General
- 10 Fund for FY2023-24 and (2) \$159,007 from the General Fund for FY2024-25
- 11 to the Supreme Court, for Program 4, to aid in carrying out the
- 12 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
- 13 Session, 2023.
- 14 Total expenditures for permanent and temporary salaries and per
- diems from funds appropriated in this section shall not exceed \$79,172
