- 1 Section 1. Section 37-421, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 37-421 (1) The commission may issue an annual combination fishing,
- 4 fur-harvesting, and hunting permit, habitat stamp, aquatic habitat stamp,
- 5 and Nebraska migratory waterfowl stamp:
- 6 (a) Upon upon application, to and payment of a fee of five dollars
- 7 to (a) any Nebraska resident who is a veteran, who is sixty-four years of
- 8 age or older, and who was discharged or separated with a characterization
- 9 of honorable or general (under honorable conditions). There shall be no
- 10 fee for a permit and stamps issued under this subdivision (1)(a); or
- 11 (b) Upon application, to any Nebraska resident who is an active duty
- 12 <u>or reserve duty member of the Armed Forces of the United States. There</u>
- shall be no fee for a permit and stamps issued under this subdivision (1)
- 14 <u>(b); and</u>
- 15 <u>(c) Upon application and payment of a fee of five dollars, to (b)</u>
- 16 any Nebraska resident who is sixty-nine years of age or older.
- 17 (2) A permit issued as provided in this section shall expire as
- 18 provided in subdivision (3)(a) of section 37-405. Permits issued under
- 19 this section as it existed before January 1, 2006, shall not expire as
- 20 provided in section 37-405.
- 21 (3) If disabled persons are unable by reason of physical infirmities
- 22 to hunt and fish in the normal manner, the commission may issue special
- 23 permits without cost to those persons to hunt and fish from a vehicle,
- 24 but such permits shall not authorize any person to shoot from any public
- 25 highway.
- 26 (4) The commission may adopt and promulgate rules and regulations
- 27 necessary to carry out this section.
