- 1 A BILL FOR AN ACT relating to appropriations; to amend section 84-612,
- 2 Revised Statutes Supplement, 2023; to provide for a transfer of
- 3 funds from the Cash Reserve Fund; to state intent to appropriate
- 4 funds to the Department of Administrative Services for Wyuka
- 5 Cemetery; to repeal the original section; and to declare an
- 6 emergency.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. It is the intent of the Legislature to appropriate
- 2 \$375,000 from the General Fund for FY2023-24 to the Department of
- 3 Administrative Services, for Program 560, to complete the capital
- 4 construction project at Wyuka Cemetery.
- 5 Sec. 2. Section 84-612, Revised Statutes Supplement, 2023, is
- 6 amended to read:
- 7 84-612 (1) There is hereby created within the state treasury a fund
- 8 known as the Cash Reserve Fund which shall be under the direction of the
- 9 State Treasurer. The fund shall only be used pursuant to this section.
- 10 (2) The State Treasurer shall transfer funds from the Cash Reserve
- 11 Fund to the General Fund upon certification by the Director of
- 12 Administrative Services that the current cash balance in the General Fund
- 13 is inadequate to meet current obligations. Such certification shall
- 14 include the dollar amount to be transferred. Any transfers made pursuant
- to this subsection shall be reversed upon notification by the Director of
- 16 Administrative Services that sufficient funds are available.
- 17 (3) In addition to receiving transfers from other funds, the Cash
- 18 Reserve Fund shall receive federal funds received by the State of
- 19 Nebraska for undesignated general government purposes, federal revenue
- 20 sharing, or general fiscal relief of the state.
- 21 (4) The State Treasurer shall transfer two million dollars from the
- 22 Governor's Emergency Cash Fund to the Cash Reserve Fund on or before June
- 23 30, 2024, on such dates and in such amounts as directed by the budget
- 24 administrator of the budget division of the Department of Administrative
- 25 Services.
- 26 (5) The State Treasurer shall transfer two hundred sixteen million
- 27 one hundred twenty thousand dollars from the Cash Reserve Fund to the
- 28 Nebraska Capital Construction Fund on or after July 1, 2022, but before
- 29 June 15, 2023, on such dates and in such amounts as directed by the
- 30 budget administrator of the budget division of the Department of
- 31 Administrative Services.

- 1 (6) The State Treasurer shall transfer one hundred eighty-two 2 million six hundred twenty-three thousand eight hundred twenty-five 3 dollars from the Cash Reserve Fund to the Nebraska Capital Construction 4 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 5 and in such amounts as directed by the budget administrator of the budget
- 6 division of the Department of Administrative Services.
- 7 (7) The State Treasurer shall transfer fifty-three million five 8 hundred thousand dollars from the Cash Reserve Fund to the Perkins County 9 Canal Project Fund on or before June 30, 2023, on such dates and in such 10 amounts as directed by the budget administrator of the budget division of
- 11 the Department of Administrative Services.
- (8) No funds shall be transferred from the Cash Reserve Fund to fulfill the obligations created under the Nebraska Property Tax Incentive Act unless the balance in the Cash Reserve Fund after such transfer will be at least equal to five hundred million dollars.
- (9) The State Treasurer shall transfer thirty million dollars from the Cash Reserve Fund to the Military Base Development and Support Fund on or before June 30, 2023, but not before July 1, 2022, on such dates and in such amounts as directed by the budget administrator of the budget division of the Department of Administrative Services.
- (10) The State Treasurer shall transfer eight million three hundred thousand dollars from the Cash Reserve Fund to the Trail Development and Maintenance Fund on or after July 1, 2022, but before July 30, 2022, on such dates and in such amounts as directed by the budget administrator of the budget division of the Department of Administrative Services.
- (11) The State Treasurer shall transfer fifty million dollars from the Cash Reserve Fund to the Nebraska Rural Projects Fund on or after July 1, 2022, but before July 15, 2023, on such dates and in such amounts as directed by the budget administrator of the budget division of the Department of Administrative Services.
- 31 (12) The State Treasurer shall transfer thirty million dollars from

- 1 the Cash Reserve Fund to the Rural Workforce Housing Investment Fund on
- 2 or after July 1, 2022, but before July 15, 2023, on such dates and in
- 3 such amounts as directed by the budget administrator of the budget
- 4 division of the Department of Administrative Services.
- 5 (13) The State Treasurer shall transfer twenty million dollars from
- 6 the Cash Reserve Fund to the Intern Nebraska Cash Fund on or after July
- 7 1, 2022, but before June 15, 2023, on such dates and in such amounts as
- 8 directed by the budget administrator of the budget division of the
- 9 Department of Administrative Services.
- 10 (14) The State Treasurer shall transfer twenty million dollars from
- 11 the Cash Reserve Fund to the Middle Income Workforce Housing Investment
- 12 Fund on July 15, 2022, or as soon thereafter as administratively
- 13 possible, and in such amounts as directed by the budget administrator of
- 14 the budget division of the Department of Administrative Services.
- 15 (15) The State Treasurer shall transfer eighty million dollars from
- 16 the Cash Reserve Fund to the Jobs and Economic Development Initiative
- 17 Fund on or after July 1, 2022, but before July 15, 2023, on such dates
- 18 and in such amounts as directed by the budget administrator of the budget
- 19 division of the Department of Administrative Services.
- 20 (16) The State Treasurer shall transfer twenty million dollars from
- 21 the Cash Reserve Fund to the Site and Building Development Fund on July
- 22 15, 2022, or as soon thereafter as administratively possible, and in such
- 23 amounts as directed by the budget administrator of the budget division of
- 24 the Department of Administrative Services.
- 25 (17) The State Treasurer shall transfer fifty million dollars from
- 26 the Cash Reserve Fund to the Surface Water Irrigation Infrastructure Fund
- 27 on or after July 15, 2022, but before January 1, 2023, on such dates and
- 28 in such amounts as directed by the budget administrator of the budget
- 29 division of the Department of Administrative Services.
- 30 (18) The State Treasurer shall transfer fifteen million dollars from
- 31 the Cash Reserve Fund to the Site and Building Development Fund on or

- 1 before June 30, 2022, on such dates and in such amounts as directed by
- 2 the budget administrator of the budget division of the Department of
- 3 Administrative Services.
- 4 (19) The State Treasurer shall transfer fifty-five million dollars
- 5 from the Cash Reserve Fund to the Economic Recovery Contingency Fund on
- 6 or before June 30, 2022, on such dates and in such amounts as directed by
- 7 the budget administrator of the budget division of the Department of
- 8 Administrative Services.
- 9 (20) The State Treasurer shall transfer ten million dollars from the
- 10 Cash Reserve Fund to the School Safety and Security Fund as soon as
- 11 administratively possible after September 2, 2023, on such dates and in
- 12 such amounts as directed by the budget administrator of the budget
- 13 division of the Department of Administrative Services.
- 14 (21) The State Treasurer shall transfer ten million dollars from the
- 15 Cash Reserve Fund to the General Fund as soon as administratively
- 16 possible after June 7, 2023, on such dates and in such amounts as
- 17 directed by the budget administrator of the budget division of the
- 18 Department of Administrative Services.
- 19 (22) The State Treasurer shall transfer one million dollars from the
- 20 Cash Reserve Fund to the Revitalize Rural Nebraska Fund as soon as
- 21 administratively possible after June 7, 2023, on such dates and in such
- 22 amounts as directed by the budget administrator of the budget division of
- 23 the Department of Administrative Services.
- 24 (23) The State Treasurer shall transfer three million dollars from
- 25 the Cash Reserve Fund to the Risk Loss Trust on or before June 30, 2024,
- 26 on such dates and in such amounts as directed by the budget administrator
- 27 of the budget division of the Department of Administrative Services.
- 28 (24) The State Treasurer shall transfer eleven million three hundred
- 29 twenty thousand dollars from the Cash Reserve Fund to the Health and
- 30 Human Services Cash Fund on or after July 1, 2023, but on or before June
- 31 30, 2024, on such dates and in such amounts as directed by the budget

- 1 administrator of the budget division of the Department of Administrative
- 2 Services.
- 3 (25) The State Treasurer shall transfer five hundred seventy-four
- 4 million five hundred thousand dollars from the Cash Reserve Fund to the
- 5 Perkins County Canal Project Fund on or before June 30, 2024, on such
- 6 dates and in such amounts as directed by the budget administrator of the
- 7 budget division of the Department of Administrative Services.
- 8 (26) The State Treasurer shall transfer one million four hundred
- 9 thousand dollars from the Cash Reserve Fund to the State Building
- 10 Revolving Fund on or before July 10, 2023, on such dates and in such
- 11 amounts as directed by the budget administrator of the budget division of
- 12 the Department of Administrative Services.
- 13 (27) The State Treasurer shall transfer one million one hundred
- 14 thousand dollars from the Cash Reserve Fund to the Accounting Division
- 15 Revolving Fund on or before July 10, 2023, on such dates and in such
- 16 amounts as directed by the budget administrator of the budget division of
- 17 the Department of Administrative Services.
- 18 (28) The State Treasurer shall transfer one million one hundred
- 19 fifteen thousand dollars from the Cash Reserve Fund to the Public Safety
- 20 Cash Fund on or after July 1, 2023, but before June 30, 2024, on such
- 21 dates and in such amounts as directed by the budget administrator of the
- 22 budget division of the Department of Administrative Services.
- 23 (29) The State Treasurer shall transfer one hundred million dollars
- 24 from the Cash Reserve Fund to the Roads Operations Cash Fund before June
- 25 30, 2023, on such dates and in such amounts as directed by the budget
- 26 administrator of the budget division of the Department of Administrative
- 27 Services.
- 28 (30) The State Treasurer shall transfer eighteen million seven
- 29 hundred fifty thousand dollars from the Cash Reserve Fund to the State
- 30 Self-Insured Indemnification Fund before June 30, 2023, on such dates and
- 31 in such amounts as directed by the budget administrator of the budget

- 1 division of the Department of Administrative Services.
- 2 (31) The State Treasurer shall transfer five million dollars from
- 3 the Cash Reserve Fund to the Nebraska Public Safety Communication System
- 4 Revolving Fund on or after July 1, 2023, but before June 30, 2024, on
- 5 such dates and in such amounts as directed by the budget administrator of
- 6 the budget division of the Department of Administrative Services.
- 7 (32) The State Treasurer shall transfer seventy million dollars from
- 8 the Cash Reserve Fund to the Shovel-Ready Capital Recovery and Investment
- 9 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 10 and in such amounts as directed by the budget administrator of the budget
- 11 division of the Department of Administrative Services.
- 12 (33) The State Treasurer shall transfer two million dollars from the
- 13 Cash Reserve Fund to the Site and Building Development Fund on or after
- 14 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 15 as directed by the budget administrator of the budget division of the
- 16 Department of Administrative Services.
- 17 (34) The State Treasurer shall transfer twenty million dollars from
- 18 the Cash Reserve Fund to the Economic Development Cash Fund on or after
- 19 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 20 as directed by the budget administrator of the budget division of the
- 21 Department of Administrative Services.
- 22 (35) The State Treasurer shall transfer zero dollars from the Cash
- 23 Reserve Fund to the Rural Workforce Housing Investment Fund on or after
- 24 July 1, 2023, but before June 30, 2024, on such dates and in such amounts
- 25 as directed by the budget administrator of the budget division of the
- 26 Department of Administrative Services.
- 27 (36) The State Treasurer shall transfer zero dollars from the Cash
- 28 Reserve Fund to the Middle Income Workforce Housing Investment Fund on or
- 29 after July 1, 2023, but before June 30, 2024, on such dates and in such
- 30 amounts as directed by the budget administrator of the budget division of
- 31 the Department of Administrative Services.

- 1 (37) The State Treasurer shall transfer two hundred forty million
- 2 dollars from the Cash Reserve Fund to the Economic Recovery Contingency
- 3 Fund on or after July 1, 2023, but before June 30, 2024, on such dates
- 4 and in such amounts as directed by the budget administrator of the budget
- 5 division of the Department of Administrative Services.
- 6 (38) The State Treasurer shall transfer ten million dollars from the
- 7 Cash Reserve Fund to the Critical Infrastructure Facilities Cash Fund on
- 8 or after July 1, 2023, but before June 30, 2024, on such dates and in
- 9 such amounts as directed by the budget administrator of the budget
- 10 division of the Department of Administrative Services.
- 11 (39) The State Treasurer shall transfer four hundred forty million
- 12 dollars from the General Fund to the Cash Reserve Fund on or after July
- 13 1, 2023, but before June 30, 2024, on such dates and in such amounts as
- 14 directed by the budget administrator of the budget division of the
- 15 Department of Administrative Services.
- 16 (40) The State Treasurer shall transfer zero dollars from the Cash
- 17 Reserve Fund to the Site and Building Development Fund on or after July
- 18 1, 2024, but before June 30, 2025, on such dates and in such amounts as
- 19 directed by the budget administrator of the budget division of the
- 20 Department of Administrative Services.
- 21 (41) The State Treasurer shall transfer one million dollars from the
- 22 Cash Reserve Fund to the General Fund on or after July 1, 2024, but
- 23 before June 30, 2025, on such dates and in such amounts as directed by
- 24 the budget administrator of the budget division of the Department of
- 25 Administrative Services.
- 26 (42) The State Treasurer shall transfer twenty-five million four
- 27 hundred fifty-eight thousand eight hundred dollars from the Cash Reserve
- 28 Fund to the Nebraska Capital Construction Fund on or after July 1, 2024,
- 29 but before June 30, 2025, on such dates and in such amounts as directed
- 30 by the budget administrator of the budget division of the Department of
- 31 Administrative Services.

- 1 (43) The State Treasurer shall transfer two million five hundred
- 2 thousand dollars from the Cash Reserve Fund to the Materiel Division
- 3 Revolving Fund on or after July 1, 2023, but before June 30, 2024, on
- 4 such dates and in such amounts as directed by the budget administrator of
- 5 the budget division of the Department of Administrative Services.
- 6 (44) The State Treasurer shall transfer ten million dollars from the
- 7 Cash Reserve Fund to the Youth Outdoor Education Innovation Fund on or
- 8 after July 1, 2023, but before June 30, 2024, on such dates and in such
- 9 amounts as directed by the budget administrator of the budget division of
- 10 the Department of Administrative Services.
- 11 (45) The State Treasurer shall transfer three hundred seventy-five
- 12 thousand dollars from the Cash Reserve Fund to the General Fund as soon
- 13 as possible after the effective date of this act, on such date as
- 14 <u>directed</u> by the budget administrator of the budget division of the
- 15 Department of Administrative Services.
- 16 Sec. 3. Original section 84-612, Revised Statutes Supplement, 2023,
- 17 is repealed.
- 18 Sec. 4. Since an emergency exists, this act takes effect when
- 19 passed and approved according to law.
