- 1 A BILL FOR AN ACT relating to Indian tribes; to amend section 81-1210.04,
- 2 Revised Statutes Cumulative Supplement, 2022; to create the Nebraska
- 3 Tribal Community Assistance Program for the purpose of providing
- 4 grants to Indian tribes to improve drinking water systems or
- 5 sanitary sewer systems as prescribed; to create the Nebraska Tribal
- 6 Community Assistance Fund; to transfer funds from the Intern
- 7 Nebraska Cash Fund; to harmonize provisions; and to repeal the
- 8 original section.
- 9 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) For purposes of this section:
- 2 (a) Department means the Department of Environment and Energy; and

- 3 (b) Eligible entity means any state-recognized Indian tribe.
- 4 (2) The Nebraska Tribal Community Assistance Program is created and
- 5 shall be administered by the department.
- 6 (3) Any eligible entity may apply to the department for a grant to
- 7 be used for the purposes described in subsection (5) of this section. The
- 8 application shall include a description of the project for which the
- 9 grant will be used and the estimated cost of such project. The
- 10 <u>application shall be on a form prescribed by the department and made</u>
- 11 <u>available on the department's website.</u>
- 12 <u>(4) The department shall award a minimum of one grant per year to</u>
- 13 <u>any eligible entity. Each such grant shall:</u>
- 14 (a) Be limited to the availability of money in the Nebraska Tribal
- 15 Community Assistance Fund; and
- 16 (b) Not exceed two million dollars.
- 17 <u>(5) Any eligible entity that is awarded a grant under the Nebraska</u>
- 18 Tribal Community Assistance Program shall:
- 19 <u>(a) Only use such grant to improve any drinking water system or</u>
- 20 <u>sanitary sewer system owned by the eligible entity or located on land</u>
- 21 <u>owned by the eligible entity; and</u>
- 22 (b) Upon demand by the department, return any grant money awarded
- 23 but not used within five years of disbursement or not used for a purpose
- 24 <u>authorized under subdivision (5)(a) of this section.</u>
- 25 (6) The department shall recoup any grant money that:
- 26 (a) Remains unused within five years of the date of disbursement of
- 27 <u>the grant; or</u>
- 28 (b) Was not used for a purpose described in subdivision (5)(a) of
- 29 this section.
- 30 Sec. 2. <u>The Nebraska Tribal Community Assistance Fund is created.</u>
- 31 The fund may consist of transfers by the Legislature and gifts, grants,

- 1 bequests, and other contributions from any public or private source. The
- 2 <u>Department of Environment and Energy shall administer the fund for the</u>
- 3 purpose of providing grants through the Nebraska Tribal Community
- 4 Assistance Program. Any money in the fund available for investment shall
- 5 be invested by the state investment officer pursuant to the Nebraska
- 6 Capital Expansion Act and the Nebraska State Funds Investment Act. Any
- 7 investment earnings from investment of money in the fund shall be
- 8 credited to the fund.
- 9 Sec. 3. Section 81-1210.04, Revised Statutes Cumulative Supplement,
- 10 2022, is amended to read:
- 11 81-1210.04 (1) The Intern Nebraska Cash Fund is created. The fund
- 12 shall be used to carry out sections 81-1210.01 to 81-1210.03. The fund
- 13 shall consist of money transferred to the fund by the Legislature and
- 14 money donated as gifts, bequests, or other contributions from public or
- 15 private entities. Any money in the fund available for investment shall be
- 16 invested by the state investment officer pursuant to the Nebraska Capital
- 17 Expansion Act and the Nebraska State Funds Investment Act.
- 18 <u>(2) Transfers may be made from the Intern Nebraska Cash Fund to the</u>
- 19 <u>Nebraska Tribal Community Assistance Fund.</u>
- 20 (3) (2) The Department of Economic Development, or any entity with
- 21 which the department contracts for such purpose, may use up to five
- 22 percent of any appropriation to carry out sections 81-1210.01 to
- 23 81-1210.03 for administrative services.
- 24 (4) The State Treasurer shall transfer ten million dollars from the
- 25 Intern Nebraska Cash Fund to the Nebraska Tribal Community Assistance
- 26 Fund as soon as administratively possible on or after the effective date
- 27 <u>of this act, on such dates and in such amounts as directed by the budget</u>
- 28 <u>administrator of the budget division of the Department of Administrative</u>
- 29 <u>Services.</u>
- 30 Sec. 4. Original section 81-1210.04, Revised Statutes Cumulative
- 31 Supplement, 2022, is repealed.
