Read first time January 12, 2023 Committee: Judiciary A BILL FOR AN ACT relating to crimes and offenses; to prohibit an 1 individual under nineteen years of age or under twenty-one years of age from being present at a drag show as prescribed; to define a term; to provide a penalty; and to prohibit a state agency from

using state funds to host a drag show. 5

Be it enacted by the people of the State of Nebraska, 6

1	Section 1. <u>(1) For purposes of this section drag show means a</u>
2	performance in which:
3	(a) The main aspect of the performance is a performer which exhibits
4	<u>a gender identity that is different than the performer's gender assigned</u>
5	at birth using clothing, makeup, or other physical markers; and
6	<u>(b) The performer sings, lip syncs, dances, or otherwise performs</u>
7	<u>before an audience for entertainment.</u>
8	<u>(2)(a) No individual under nineteen years of age shall be present at</u>
9	<u>a drag show. Any person nineteen years of age or older who knowingly</u>
10	<u>brings an individual under nineteen years of age to a drag show shall be</u>
11	<u>guilty of a Class I misdemeanor.</u>
12	<u>(b) No individual under twenty-one years of age shall be present at</u>
13	<u>a drag show if alcoholic liquor is being served at such location.</u>
14	<u>(3)(a) Any business, establishment, or nonprofit that hosts a drag</u>
15	<u>show and allows an individual (i) under nineteen years of age in</u>
16	violation of subdivision (2)(a) of this section or (ii) under twenty-one
17	years of age in violation of subdivision (2)(b) of this section to be
18	present at a drag show shall be fined ten thousand dollars for each
19	violation of this section. Any fines collected under this section shall
20	be remitted to the State Treasurer for distribution in accordance with
21	Article VII, section 5, of the Constitution of Nebraska.
22	<u>(b) An officer or owner of a business, establishment, or nonprofit</u>
23	<u>that hosts a drag show and knowingly allows an individual (i) under</u>
24	nineteen years of age in violation of subdivision (2)(a) of this section
25	or (ii) under twenty-one years of age in violation of subdivision (2)(b)
26	<u>of this section to be present at a drag show shall be guilty of a Class I</u>
27	<u>misdemeanor.</u>
28	(4) No state agency that receives state funds shall use such funds
29	<u>to host a drag show.</u>
