9 Be it enacted by the people of the State of Nebraska,

Section 1. Section 81-2,239, Revised Statutes Cumulative Supplement,
 2022, is amended to read:

81-2,239 Sections 81-2,239 to 81-2,292 and sections 3, 5, 6, and 7
of this act and the provisions of the Food Code and the Current Good
Manufacturing Practice In Manufacturing, Packing, or Holding Human Food
adopted by reference in sections 81-2,257.01 and 81-2,259, shall be known
and may be cited as the Nebraska Pure Food Act.

8 Sec. 2. Section 81-2,240, Revised Statutes Cumulative Supplement,
9 2022, is amended to read:

10 81-2,240 For purposes of the Nebraska Pure Food Act, unless the 11 context otherwise requires, the definitions found in sections 81-2,241 to 12 81-2,254 <u>and section 3 of this act</u>shall be used. In addition, the 13 definitions found in the code and practice adopted by reference in 14 sections 81-2,257.01 and 81-2,259 shall be used.

15 Sec. 3. <u>Guidance document has the same meaning as in section</u> 16 <u>84-901.</u>

Sec. 4. Section 81-2,251.04, Reissue Revised Statutes of Nebraska,is amended to read:

19 81-2,251.04 Mobile food unit shall mean a vehicle mounted food
20 establishment designed to be readily movable that returns to a commissary
21 daily for cleanup and service.

22 Sec. 5. <u>(1) A political subdivision under contract with the</u> 23 <u>department to perform regulatory functions authorized pursuant to the</u> 24 <u>Nebraska Pure Food Act may enter into an agreement under the Interlocal</u> 25 <u>Cooperation Act with one or more participating political subdivisions to</u> 26 <u>grant and recognize health inspection permits for mobile food units.</u>

27 (2) A participating political subdivision may refuse to recognize a
 28 mobile food unit's health inspection permit. If the permit is not
 29 recognized, the mobile food unit operator shall be provided with written
 30 notice regarding the basis for this decision.

31 (3) The mobile food unit may be subject to periodic and unannounced

inspections in any jurisdiction where its health inspection permit is recognized. Political subdivisions shall utilize discretion when inspecting mobile food units that are authorized to operate in multiple jurisdictions to ensure inspection is no more frequent than necessary to protect public health and safety. A mobile food unit shall allow the political subdivision or its agent access for inspection when the mobile food unit is physically operating in its jurisdiction.

8 <u>(4) Fees for inspections conducted in a participating political</u> 9 <u>subdivision's public health department's jurisdiction shall be limited to</u> 10 <u>the administrative costs incurred by the participating political</u> 11 <u>subdivision's public health department to complete the inspection.</u>

Sec. 6. (1) For purposes of this section, city means a city of the
 first class or a city of the second class.

14 (2) Any city that does not regulate the operation of mobile food 15 units in any way shall submit to the department for publication on a 16 registry a written statement confirming that no mobile food unit 17 ordinances exist. The department shall post such registry on its website. 18 (3) The department may adopt and promulgate rules and regulations to 19 carry out this section.

20 Sec. 7. <u>The department shall develop and make available to the</u> 21 <u>public a guidance document for mobile food unit operators. The guidance</u> 22 <u>document shall include all health and safety requirements a mobile food</u> 23 <u>unit operator must demonstrate in order to receive approval for a health</u> 24 <u>inspection permit pursuant to section 5 of this act.</u>

25 Sec. 8. Original section 81-2,251.04, Reissue Revised Statutes of 26 Nebraska, and sections 81-2,239 and 81-2,240, Revised Statutes Cumulative 27 Supplement, 2022, are repealed.
