LEGISLATIVE BILL 799A

Introduced by DeBoer, 10.

Read first time April 05, 2023

1 A BILL FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 799, One Hundred
3 Eighth Legislature, First Session, 2023; and to declare an
4 emergency.

5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$102,024 from the
2 General Fund for FY2023-24 and (2) \$194,964 from the General Fund for
3 FY2024-25 to the Supreme Court, for Program 3, to aid in carrying out the
4 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
5 Session, 2023.

6 Total expenditures for permanent and temporary salaries and per
7 diems from funds appropriated in this section shall not exceed \$102,024
8 for FY2023-24 or \$194,964 for FY2024-25.

9 Sec. 2. There is hereby appropriated (1) \$83,221 from the General
10 Fund for FY2023-24 and (2) \$159,007 from the General Fund for FY2024-25
11 to the Supreme Court, for Program 4, to aid in carrying out the
12 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
13 Session, 2023.

14 Total expenditures for permanent and temporary salaries and per
15 diems from funds appropriated in this section shall not exceed \$83,221
16 for FY2023-24 or \$159,007 for FY2024-25.

17 Sec. 3. There is hereby appropriated (1) \$946,258 from the General
18 Fund for FY2023-24 and (2) \$1,807,806 from the General Fund for FY2024-25
19 to the Supreme Court, for Program 6, to aid in carrying out the
20 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
21 Session, 2023.

22 Total expenditures for permanent and temporary salaries and per
23 diems from funds appropriated in this section shall not exceed \$946,258
24 for FY2023-24 or \$1,807,806 for FY2024-25.

25 Sec. 4. There is hereby appropriated (1) \$763,611 from the General
26 Fund for FY2023-24 and (2) \$1,458,726 from the General Fund for FY2024-25
27 to the Supreme Court, for Program 7, to aid in carrying out the
28 provisions of Legislative Bill 799, One Hundred Eighth Legislature, First
29 Session, 2023.

30 Total expenditures for permanent and temporary salaries and per
31 diems from funds appropriated in this section shall not exceed \$763,611

1 for FY2023-24 or \$1,458,726 for FY2024-25.

2 Sec. 5. There is hereby appropriated (1) \$89,937 from the General
3 Fund for FY2023-24 and (2) \$172,422 from the General Fund for FY2024-25
4 to the Nebraska Workers' Compensation Court, for Program 526, to aid in
5 carrying out the provisions of Legislative Bill 799, One Hundred Eighth
6 Legislature, First Session, 2023.

7 Total expenditures for permanent and temporary salaries and per
8 diems from funds appropriated in this section shall not exceed \$89,937
9 for FY2023-24 or \$172,422 for FY2024-25.

10 Sec. 6. Since an emergency exists, this act takes effect when
11 passed and approved according to law.
