- 1 A BILL FOR AN ACT relating to the Department of Economic Development; to
- 2 amend section 81-1210.02, Revised Statutes Cumulative Supplement,
- 3 2022; to change provisions relating to internship grants; to provide
- 4 an operative date; to repeal the original section; and to declare an
- 5 emergency.
- 6 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-1210.02, Revised Statutes Cumulative
- 2 Supplement, 2022, is amended to read:
- 3 81-1210.02 (1) The intent of sections 81-1210.01 to 81-1210.03 is to
- 4 provide students with valuable internship opportunities in order to
- 5 retain such students in the State of Nebraska at institutions of higher
- 6 education, convert students to full-time employment in Nebraska, and
- 7 attract workers to Nebraska by assisting Nebraska businesses willing to
- 8 provide paid internships.
- 9 (2) A business may apply to the department for a grant to assist in
- 10 providing a student an internship if:
- 11 (a) The business certifies that the internship meets the definition
- of internship in section 81-1210.01;
- 13 (b) The business will pay the student at least the state minimum
- 14 hourly wage for the internship;
- (c) The internship will be completed within the State of Nebraska;
- 16 (d) The internship will be completed within a period of no more than
- 17 twenty-four months; and
- 18 (e) The internship will be for a duration sufficient to allow the
- 19 student to gain significant valuable work experience and knowledge.
- 20 (3)(a) The department may provide grants for internships to
- 21 reimburse the cost of wages paid to businesses with less than one hundred
- 22 fifty full-time-equivalent employees.
- 23 (b) The department may also provide grants for internships to any
- 24 business to reimburse the costs for any of the following:
- 25 (i) Tuition reimbursement for courses at institutions of higher
- 26 education;
- 27 (ii) Internship housing;
- 28 (iii) Transportation expenses relating to internships; and
- 29 (iv) Internship administrative or recruitment costs.
- 30 (c) The maximum grant award per internship is seven thousand five
- 31 hundred dollars.

- 1 (4) A business may apply for no more than two grants for the same
- 2 student and shall not be awarded more than one hundred grants total in
- 3 any twelve-month period.
- 4 (5) A business may allow a student to telecommute if the business is
- 5 located more than thirty miles from the college, university, or other
- 6 institution of higher education in which the student is enrolled and if
- 7 the college, university, or other institution of higher education is in
- 8 Nebraska.
- 9 (5) The department shall, to the extent possible, assure that
- 10 the distribution of grants under sections 81-1210.01 to 81-1210.03
- 11 provides equitable access to the grants by all geographic areas of the
- 12 state.
- 13 (6) (7) The department shall, to the extent possible, assure that
- 14 the grants awarded pursuant to sections 81-1210.01 to 81-1210.03 are for
- 15 internships which provide valuable learning opportunities for students
- 16 who will be seeking employment in a professional or technical field.
- 17 (7) (8) The department shall not allocate more than one million five
- 18 hundred thousand dollars in any one fiscal year from the Job Training
- 19 Cash Fund or its subaccounts for purposes of this section. The department
- 20 may receive funds from public, private, or other sources for purposes of
- 21 this section.
- 22 (8) (9) The department shall develop a qualified action plan by
- 23 January 1 of each even-numbered year. The plan shall, at a minimum, set
- 24 forth the department's priorities and selection criteria for awarding
- 25 grants for internships. In order to encourage students from across
- 26 Nebraska to pursue internships, the plan shall also include strategies
- 27 for affirmatively marketing internships to Nebraska students in high
- 28 schools, colleges, universities, and other institutions of higher
- 29 education in Nebraska. Such strategies shall place an emphasis on
- 30 marketing to underserved student populations as defined by the department
- 31 in the plan. The department shall submit the plan to the Governor for

- 1 approval.
- 2 (9) (10) The department shall execute a memorandum of understanding
- 3 with the Department of Labor before December 31, 2022, to ensure the
- 4 exchange of available Department of Labor data throughout the continuum
- 5 from prekindergarten to postsecondary education to the workforce. The
- 6 department may utilize data and agreements under sections 79-776, 85-110,
- 7 85-309, and 85-1511.
- 8 (10) (11) The department shall submit an annual report to the
- 9 Governor and the Legislature on or before July 1 of each year which
- 10 includes, but is not limited to, a description of the demand for
- 11 internship grants and programs under sections 81-1210.01 to 81-1210.03
- 12 from all geographic regions in Nebraska, a listing of the recipients and
- 13 amounts of internship grants awarded in the previous fiscal year, the
- 14 impact of the internship grants, and an evaluation of the internship
- 15 grants and programs under sections 81-1210.01 to 81-1210.03 based on the
- 16 documented goals of the recipients. The report submitted to the
- 17 Legislature shall be submitted electronically. The department may require
- 18 recipients to provide periodic performance reports to enable the
- 19 department to fulfill the requirements of this subsection. The report
- 20 shall contain no information that is protected by state or federal
- 21 confidentiality laws.
- 22 (11) (12) The department may enter into a contract with a Nebraska-
- 23 based nonprofit entity for the purposes of carrying out any or all of the
- 24 provisions of sections 81-1210.01 to 81-1210.03.
- 25 Sec. 2. This act becomes operative on July 1, 2024.
- 26 Sec. 3. Original section 81-1210.02, Revised Statutes Cumulative
- 27 Supplement, 2022, is repealed.
- 28 Sec. 4. Since an emergency exists, this act takes effect when
- 29 passed and approved according to law.
