- 1 A BILL FOR AN ACT relating to the State Athletic Commissioner; to amend 2 sections 81-8,129, 81-8,130.01, 81-8,132, 81-8,133, 81-8,133.01, 3 81-8,134, 81-8,135, 81-8,138, and 81-8,139, Revised Statutes 4 Cumulative Supplement, 2022; to provide powers and duties to the 5 State Athletic Commissioner relating to the regulation 6 professional bare-knuckle mixed martial arts, amateur kickboxing, 7 amateur bare-knuckle boxing, amateur bare-knuckle mixed martial 8 arts, and amateur sparring matches and exhibitions; to harmonize 9 provisions; and to repeal the original sections.
- 10 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 81-8,129, Revised Statutes Cumulative Supplement,
- 2 2022, is amended to read:
- 3 81-8,129 The State Athletic Commissioner shall have sole direction,
- 4 management, control, and jurisdiction over all professional mixed martial
- 5 arts, professional boxing, professional kickboxing, professional bare-
- 6 knuckle boxing, professional bare-knuckle mixed martial arts, and
- 7 professional sparring matches and exhibitions and all amateur mixed
- 8 martial arts, amateur kickboxing, amateur bare-knuckle boxing, amateur
- 9 <u>bare-knuckle mixed martial arts, and amateur sparring</u> matches and
- 10 exhibitions to be held within the state, except such as are conducted by
- 11 universities, colleges, high schools, the military, and recognized
- 12 amateur associations for contestants under sixteen years of age. No
- 13 professional boxers, professional mixed martial arts contestants,
- 14 professional kickboxers, <u>professional bare-knuckle mixed martial arts</u>
- 15 <u>contestants,</u> professional bare-knuckle boxers, or amateur mixed martial
- 16 arts contestants, amateur kickboxers, amateur bare-knuckle boxers, or
- 17 <u>amateur bare-knuckle mixed martial arts contestants,</u> who have attained
- 18 the age of sixteen, shall participate in a match or exhibition for a
- 19 prize or purse, or at which an admission fee is charged, either directly
- 20 or indirectly, in the form of dues or otherwise, in this state except by
- 21 a club, association, organization, or person licensed by the
- 22 commissioner, as provided in section 81-8,130, and in pursuance of a
- 23 license granted by the commissioner for such match or exhibition under
- 24 section 81-8,130.01.

- 27 81-8,130.01 Licenses and permits may be issued to professional mixed
- 28 martial arts, professional boxing, professional kickboxing, or
- 29 professional bare-knuckle boxing, or professional bare-knuckle mixed
- 30 marti<u>al arts</u> promoters, whether persons, clubs, or associations, for the
- 31 sole purpose of conducting professional matches under such rules and

The referee shall stop the match 3 4 whenever he or she deems it advisable, (1) because of the physical 5 condition of the contestants or one of them, (2) when one of the contestants is clearly outclassed by his or her opponent, or (3) for any 6 other sufficient reason. The referee shall, at the termination of every 7 professional boxing, professional mixed martial arts, professional 8 9 kickboxing, professional bare-knuckle boxing, professional bare-knuckle mixed martial arts, amateur mixed martial arts, amateur kickboxing, 10 amateur bare-knuckle boxing, amateur bare-knuckle mixed martial arts, 11 amateur sparing, or professional sparring match or exhibition, indicate a 12 13 winner. The fees of the referee and other licensed officials may be fixed by the commissioner and shall be paid by the licensed organization. 14

17 81-8,133.01 The State Athletic Commissioner may grant licenses to qualified physicians, managers, matchmakers, and professional mixed 18 martial arts, professional boxing, professional kickboxing, professional 19 bare-knuckle boxing, professional bare-knuckle mixed martial arts, or 20 professional sparring match or exhibition judges upon an application and 21 payment of an annual fee set by the commissioner in rule and regulation. 22 Such fee for matchmakers shall be not less than ten dollars and not more 23 24 than one hundred dollars. Such fee for physicians, managers, 25 professional mixed martial arts, professional boxing, professional kickboxing, professional bare-knuckle boxing, professional bare-knuckle 26 mixed martial arts, or professional sparring match or exhibition judges 27 28 shall be not less than ten dollars and not more than twenty dollars. The commissioner 29 may also grant licenses to qualified timekeepers, contestants, and seconds upon an application and payment of an annual fee 30 set by the commissioner in rule and regulation. - 7 such. No person shall serve as timekeeper or contestant at any

- 10 knuckle mixed martial arts match who is not licensed as such. The
- 11 commissioner shall have summary authority to stop any match at which any

Sec. 8. Section 81-8,138, Revised Statutes Cumulative Supplement, 2022, is amended to read:

81-8,138 No contestant in any match or exhibition shall be paid for 19 services until the same are rendered, and should it be determined by the 20 State Athletic Commissioner that a contestant did not give an honest 21 exhibition of his or her skill, he or she shall not be paid. Any 22 contestant who shall participate in any sham or fake professional boxing, 23 24 professional mixed martial arts, professional kickboxing, professional 25 bare-knuckle boxing, professional bare-knuckle mixed martial arts, or amateur mixed martial arts, amateur kickboxing, amateur bare-knuckle 26 boxing, or amateur bare-knuckle mixed martial arts match or exhibition 27 shall be disqualified and shall not thereafter be permitted to contend in 28 any match or exhibition in this state, and any contestant who shall 29 participate in any sham or fake professional boxing, professional mixed 30 martial arts, professional kickboxing, professional bare-knuckle boxing, 31

- 7 81-8,139 (1) Except as provided in subsection (2) of this section, the State Athletic Commissioner shall adopt and promulgate such rules and 8 9 regulations for the administration and enforcement of sections 81-8,128 10 to 81-8,142.01 as he or she may deem necessary. Such rules and regulations shall include, but not be limited to, the establishment of 11 written criteria for the granting and revoking of licenses, the setting 12 of license fees, and the qualification requirements for those to be 13 licensed as referees, physicians, managers, matchmakers, and professional 14 boxing, professional mixed martial arts, professional kickboxing, amateur 15 kickboxing, professional bare-knuckle boxing, 16 amateur bare-knuckle 17 boxing, professional bare-knuckle mixed martial arts, amateur bareknuckle mixed martial arts, or professional sparring, or amateur sparring 18 19 match or exhibition judges. He or she may fine any 26 27 licensee, except amateur contestants, an amount not to exceed one thousand dollars and may suspend for a period, not to exceed one year, 28 any licensee's right to participate in or conduct any match or exhibition 29 for unsportsmanlike conduct while engaged in or arising directly from any 30

match or exhibition, failure to compete in good faith, engaging in any

sham match or exhibition, or the use of threatening and abusive language toward officials, other contestants, or spectators.

- (2) The State Athletic Commissioner may adopt and promulgate rules and regulations to identify a list of substances banned for use by any amateur or professional contestant and may require any contestant to submit to a test for banned substances as a condition for allowing the contestant's participation in a match or exhibition.
- (3) The State Athletic Commissioner may suspend an amateur or 8 9 professional contestant from competition for a period not to exceed one year and may fine a professional contestant an amount not to exceed one 10 thousand five hundred dollars or forty percent of the prize or purse, 11 whichever is greater, for a first offense of failing a test for a banned 12 13 substance on the list developed pursuant to subsection (2) of this section or for refusing to submit to such a test. He or she may suspend 14 an amateur or professional contestant from competition for a period not 15 16 to exceed three years and may fine a professional contestant an amount 17 not to exceed three thousand dollars or seventy percent of the prize or purse, whichever is greater, for any second such offense. He or she may 18 19 suspend an amateur or professional contestant from competition for life and may fine a professional contestant an amount not to exceed five 20 thousand dollars or one hundred percent of the prize or purse, whichever 21 22 is greater, for any third or subsequent such offense. For purposes of determining if an offense under this subsection is a first, second, 23 24 third, or subsequent offense, failing a test for banned substances and 25 refusing to submit to such a test shall be considered the same offense.
 - (4) Before levying an administrative fine pursuant to this section, the State Athletic Commissioner shall set the matter for hearing. Proceedings to levy an administrative fine shall be contested cases prosecuted and appealable pursuant to the Administrative Procedure Act. At least ten days before the hearing, the State Athletic Commissioner shall serve notice of the time, date, and place of the hearing upon the
