ARCH: Good morning, Senators. Welcome to the George W. Norris Legislative Chamber for the second day of the One Hundred Eighth Legislature, First Session. Our chaplain for today is Senator DeBoer. Please rise.

DeBOER: Oh, Holy One, in this season of new beginnings, bring hope to all who work here, hope that the world not-- need not be as it has always been, but that you bring surprises in our midst. Embolden us with visions of change. In this place, as we set off on the work of shepherding the state, help us to see your divine face in each one who works here with us. Move within us a spirit of charity and compassion to each other and to all those in our state. We thank you for our new Governor and Lieutenant Governor as they begin their service today. Bring wisdom and patience and strength to them. We thank you for the work of all the new and returning staff members who work for the Legislature. Bring blessings on their service as they begin new tasks and learn new roles. We thank you for all the support workers in this building who make it possible for us to do our work: the custodians and technical supporters, all of those we've seen moving people in this office, the reporters, and yes, the lobbyists. Bring courage and patience and kindness and wisdom and strength to each person who labors here. Bless our service together. In the name of the one who is, who was, and always will be, amen.

ARCH: Senator Albrecht, you're recognized for the Pledge of Allegiance.

ALBRECHT: Thank you, Mr. Speaker. Please join me. I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

ARCH: Thank you, Senator. I call to order the second day of the One Hundred Eighth Legislature, First Session. Senators, please record your presence. Roll call. Mr. Clerk, please record.

CLERK: There is a quorum present, Mr. President.

ARCH: Thank you, Mr. Clerk. Do you have any corrections for the Journal?

CLERK: I have no corrections this morning.

And finally, Mr. President, a preliminary report from the Committee on Committees concerning appointments to the standing committees. That's all I have at this time, Mr. President.

ARCH: Thank you, Mr. Clerk. Senator Albrecht, you are recognized for an announcement. And members, please come to order.

ALBRECHT: Thank you, Mr. Speaker. Committee on Committees did meet yesterday afternoon to deliver the preliminary slate. I would like, if there's any changes, that everyone return to their designated chairfolks that are selected, the four that will be in Committee on Committees this afternoon, with any changes. Make sure you see them before noon. And I'd like to request the Committee on Committees to meet under the north balcony as soon as we get done here. Thanks.

ARCH: Thank you, Senator Albrecht. Senator Conrad, you are recognized for a point of personal privilege.

CONRAD: Thank you, Mr. Speaker, and good morning, colleagues. It's my honor to have an opportunity to mark a really special aspect of state

law. Under the current Nebraska Revised Statutes 84-104.04, which was adopted back in 1981, and 84-104.05, adopted contemporaneously thereto, our state saw fit to recognize appropriately that today, January 5 of each year, shall be designated as George W. Norris Day, and shall be set apart for holding suitable exercises in the schools and in state government to recognize the achievements and accomplishments of this great Nebraskan, which of course includes the establishment of this unique, special, effective and efficient nonpartisan Unicameral Legislature, which is the envy of our peers across our sister states and I think perhaps even the federal government. With that being said, I know that Senator McCollister helped to start this tradition in years past, and he read into the record the first speech that Senator Norris provided to the Unicameral Legislature back in 1937. I will spare you reading the full speech because you can find it for yourself in the record, or we'd be happy to go ahead and pass it out so that people can have that available. But I think it's right to not only recognize this day in our state law, but to set the tone for our work ahead, to remember the institution that we have sworn an oath to protect and defend as we carry our work forward. So to quote Senator Norris from his first speech to the Legislature, remember this: every professional lobbyist, professional politician and representative of greed and monopoly is hoping and praying that our-- your work will be a failure. Everything that special interests can do to embarrass you and misinterpret your actions will be attempted. On the other hand, every lover of his fellow man, every person who wants to place our state on a higher standard of efficiency, every person who's anxious to bring about improvement in our state affairs, every patriot who wants to place our government on a higher level of good, every lover of human liberty and equal justice, every believer in the business administration of state affairs as distinguished from the political machine control is hoping, praying, and believing that our official work will be crowned with unlimited success and satisfaction. Remember this, that we are serving without regard to partisan, political obligation or any machine or any boss or any political leader. Our constituents do not expect perfection. They know that it is human to err, but they do expect and have the right to expect absolute honestly-- honesty, unlimited courage and a reasonable degree of efficiency and wisdom. I encourage each of our colleagues, returning and new, to reflect on George Norris today, as marked in our state law and as marked in our traditions. It is critical that we honor these traditions. It is critical we honor our state law. It is critical we honor our oath to defending our nonpartisan institution, which is enshrined in our state constitution. Thank you, Mr. President.

ARCH: Thank you, Senator Briese. Senator Clements would like to recognize our doctor for the day, Dr. Dale Michels from Walton, Nebraska, who is seated under the balcony. Please rise and welcome Dr. Michels. We will now proceed to the introduction of new bills. Mr. Clerk.

CLERK: Mr. President, quickly, if I could, first, announcement: the Exec-- excuse me, the Committee on Committees will meet in Executive Session now under the north balcony. Committee on Committees, now under the north balcony. New bills: LB1, introduced by Senator Briese, as Chair of the Executive Board. It's a bill for an act relating to agriculture; eliminates obsolete funds that have been terminated; and outright repeals several sections. LB2, introduced by Senator Sanders, is a bill for an act relating to government; creates the Commission on Asian American Affairs. LB3, introduced by Senator Sanders, a bill for an act relating to bonds; amends several sections; changes provisions relating to levying of taxes for bond sinking funds; provides for the levying of taxes for bonds prior to the bond being issued and a deadline for notifying the county assessor of approved bonds in order to correct valuation of property; harmonize provisions; and repeals the original section. LB4, introduced by Senator Sanders, is a bill for an act relating to homestead exemptions; amends several sections; changes provisions relating to veterans who qualify for exemption, application requirements, and penalties; harmonize provisions; provides an operative date; and repeals the original section. LB5, introduced by Senator Blood, is a bill for an act relating to the

Nebraska Workers' Compensation Act; amends section 48-101.01; provides for comp-- compensability of mental injuries and mental illness resulting from workplace violence; defines a term; harmonize provisions; and repeals the original section. LB6, introduced by Senator Blood, is a bill for an act relating to political subdivisions; amends several sections; prohibits granting conditional use permit to persons delinquent in the payment of real property taxes, provides a waiver as prescribed; provides duties, a contracting requirement, and a waiver under the Community Development Law; harmonize provisions; provides a duty for the Revisor of Statutes; and repeals the original section. LB7, introduced by Senator Blood, is a bill for an act relating to civil actions; amends section 25-224; provides for a statute of limitations for actions based on the exposure to hazardous or toxic chemicals; harmonize provisions; and repeals the original section. LB8, introduced by Senator Blood, is a bill for an act relating to mobile homes; amends several sections; changes and eliminates provisions under the Mobile Home Landlord and Tenant Act relating to rules and regulations, prohibited acts, termination of tenancy, landlord remedies, retaliational [SIC] conduct and abandonment; and provides for in-park sales; creates liens on landowners-- land-- excuse me, landlords as prescribed and provides for certificates of title, priority, enforcement, and challenges; eliminates obsolete provisions; provides for applicability; defines terms; harmonize provisions; repeals the original section; outright repeals section 76-14, 101. LB9, introduced by Senator Blood, is a bill for an act relating to Nebraska Political, Political Accountability and Disclosure Act; amends several sections; defines a term; changes reporting requirements for independent expenditures; requires reporting regarding electioneering communications; provides for late filing fees; to provide a penalty; harmonize provisions; repeals the original section. LB10, introduced by Senator Blood, is a bill for an act relating to revenue and taxation; amends several sections; changes a motor vehicle tax exemption and property tax exempt relating to certain disabled veterans; harmonize provisions; provides an operative date; and repeals the original section. LB11, introduced by Senator Blood, is a bill for an act relating to Protection from Domestic Abuse Act; amends sections 42-903 and 42-924; defines a term; provides for additional relief for protection orders as prescribed; repeals-- and repeals the original section. LB12, introduced by Senator Blood, is a bill for an act relating to human breast milk; creates the Nebraska Human Breast, Breast Milk Bank. LB13, introduced by Senator Blood, is a bill for an act relating to the Medical Assistance Act; amends sections 68-901 and 68-911; requires coverage of human breast milk; and repeals the original

section. LB15, introduced by Senator Briese, is a bill for an act relating to the Wage and Hour Act; amends section 48-1203.01 and section 48-1203; provides youth minimum wage as prescribed; changes provisions relating to training wage wait-- wage rate; harmonize provisions; and repeals the original sections. LB16, introduced by Senator Briese, is a bill for an act relating to occupational licenses; amends several sections of Chapter 84; changes provisions for membership of the State Electrical Board; provides powers and duties for the State Electrical Board; defines a term; provides for federal preemption; provides for applicability of provisions; requires occupational boards to make a determination regarding the applicant with a criminal conviction; requires occupational boards to issue occupational license or government certificate based on the occupational licensure, government certification, private certification, or work experience in another state or in the United States Military; provides for jurisprudential examinations and appeals from denial of license; changes provisions relating to preliminary applications by individuals with criminal conviction; harmonize provisions; repeals the original section. LB17, introduced by Senator Dungan, is a bill for an act relating to firearms; authorizes possession of a firearm on school grounds by full-time, off-duty peace officers; and repeals the original section. LB18 by Senator Wayne. It's a bill for an act relating to criminal procedure; amends section 29-2101 and 29-2103; changes provisions relating to motions for a new trial; provides for applicability; and repeals the original section. LB19, introduced by Senator Wayne, is a bill for an act related to crimes and offenses; amends several sections; changes dollar amount thresholds for criminal penalties of certain offenses; redefines terms; provides for applicability of changes; eliminates obsolete provisions; harmonizes provisions; and repeals the original section. LB20, introduced by Senator Wayne, is a bill for an act relating to voting rights; amends sections 29-112, 29-1113 [SIC], 32-313, and 32-1530; provides for the restoration of voting rights upon completion of a felony sentence; harmonizes provisions; and repeals the original section. LB21, introduced by Senator Wayne, is a bill for an act relating to cities of the metropolitan class; amends several sections; changes provisions relating to elections, districts, terms, number of

city council members, and redistricting, redistricting procedures; harmonizes provisions; repeals the original section. LB23, introduced by Senator Wayne, is a bill for an act relating to paternity; amends sections 43-1401 and section 43-1411; defines and redefines terms; changes provisions relating to interventions in paternity actions; and harmonizes provisions; and repeals the original section. LB24, introduced by Senator Wayne, is a bill for an act relating to Tobacco Products Tax Act; amends section 77-4008; changes provisions relating to tax on cigars, cheroots, stogies as prescribed; provides an operative date; and repeals the original sections. LB25, introduced by Senator Wayne, is a bill for an act relating to courts; states findings; defines terms; authorizes punitive damages as prescribed. LB26, introduced by Senator Wayne, is a bill for an act relating to municipalities; amends section 86-594; to adopt the Rural Municipal Broadband Access Act; harmonizes provisions; provides a duty for the Revisor of Statutes; and repeals the original section. LB27, introduced by Senator Dungan, is a bill for an act relating to criminal procedure; amends section 29-2318; provides for appointment of counsel for defendants; and repeals the original section. LB28, introduced by Senator Erdman, is a bill for an act relating to taxate-- Tax Equalization and Review Commission [SIC]; amends section 77-5015; change provisions relating decisions on appeals; repeals the original section; declares an emergency. That's all I have at this time, Mr. President.

DORN: Mr. Clerk-- Mr. Speaker, you're recognized for an announcement.

ARCH: Thank you, Mr. President. Colleagues, I am going to be distributing a schedule, a memo this morning and I want to talk you through it. They'll distribute it right after I'm done speaking here for a second, but if I could have your attention for a minute. I want to, I want to talk to you about a-- one, one change that is-- that probably might catch you a little by surprise, something we're going to do a little bit differently this year. So my observation over the first four years is that we spend a lot of time in the beginning of the session waiting for bills, waiting for floor debate, waiting-- we do a lot of waiting at the beginning of the session. Then we get to the end of the session and we're here at 10:00 at night and I'm-- and so what I would like to do is, is I would really-- if at all possible,

I'd like to kind of smooth out the load over the session to avoid-- especially at the end of the session. I mean, it-- sometimes it feels as though sometimes we're like the poor student that doesn't get their work done at the beginning of the semester and then crams for all-nighters at the end of the, at the end of the semester. I'd kind of like to smooth that out a little bit and so I'm going to make an attempt to do that with, with the scheduling. So that's, that's what's behind this. So the memo's-- the memo-- just-- and you'll, you'll, you'll get all the detail here in just a second. But the-- this next week, we're-- the Rules Committee will be meeting. They'll be working on that. We'll be doing bill introductions next week. That will be as, as expected. January 17, we'll begin Rules debate on the 17th. The 18th, by the way, is the last day of bill introduction so be sure and mark that on your calendar to get the, get the bills in. And then beginning January 23 through 27, we'll be-- begin committee hearings. We'll begin with half-day committee hearings the 23rd through the 27th. We have a number of new, new clerks that are assuming responsibilities. We want to give them a little bit of time to ease into the committee responsibilities so the 23rd through the 27th will be half days. But here's where, here's where I'd like to try something a little bit different. When we were in COVID, of course, many of us remembered the full-day committee hearings. And frankly, we all said, like, don't do that again because-- especially when it was like that was all we were doing all day long. It was a tremendous burden on the committee clerks. But one of the things I would like to do is I would, I would like to do all-day committee hearings January 30 through February 10, so two weeks. And there's a, there's a day in there that's just a half day because of, of, of other, of other of-- obligations and a recess day February 6. But I would like to try to frontload the session a little bit with some all-day hearings and get bills moving so that when we begin debate on February 13, that we've got good bills. And, and, and some of those will be priority bills and we'll be, we'll be ready to tackle the, the responsibilities that we have. So you'll see that in the, in the memo. The only thing that I would, I would also mention is that April 11 through June 2, I'm, I'm-- I-- as I said, my goal is I, I just don't think we make tremendously good decisions at 10:00 at night. After long days, we're all tired. So I would really like to stay off evenings, but I am asking you to keep the evenings open from April 11 through June 2 and hopefully we don't-- we'll use those very sparingly, if at all. That's, that's my goal. So I would also ask for today that you please review the agenda for the day. You have all been given assignments for escorting. Please note what, what you are escorting into the room for the swearing in ceremonies because we aren't going to announce those

LB29, introduced by Senator Erdman, is a bill for an act relating to property taxes; amends several sections within Chapter 77; changes provisions relating to the assessment of real property that suffers significant property damage; redefines and eliminates terms; harmonizes provisions; and repeals the original section; declares an emergency. LB30, introduced by Senator Dungan, is a bill for an act relating to the Nebraska Juvenile Code; amends sections 43-279 and 43-280; provides for answers of no contest in adjudication hearings; harmonizes provisions; and review-- and repeals the original section. LB31, introduced by Senator Jacobson. It's a bill for an act relating to railroads; requires a train crew of at least two individuals as prescribed; provides fines; and provides duties for the Public Service Commission. LB32, introduced by Senator Jacobson. It's a bill for an act relating to Medical Supplement Insurance Minimum Standards Act; amends section 44-3601; changes provisions relating requirements for issuers of Medicare supplement insurance policies or certificates that-- and coverage of individuals under sixty-five years of age who are eligible for Medicare by reason of disability or end-stage renal, renal disease; harmonizes provisions; repeals the original section. LB33, introduced by Senator Jacobson, is a bill for an act relating to municipalities; amends several sections; changes provisions relating to voting powers of mayors of cities of the first class and cities of the second class; eliminates obsolete provisions relating to revised election district boundaries; harmonizes provisions; repeals the original section. LB34, introduced by Senator Dungan, is a bill for an act relating to the administration of justice; amends several sections; provides a presumption of disposition under the Nebraska Juvenile Code for crimes committed by defendants under eighteen years of age; changes the definition of juvenile under the Nebraska Juvenile Code; and repeals the original section. LB35, introduced by Senator DeBoer, is a bill for an act relating to child care; amends sections 68-1206 and 68-1724; adopts changes to federal law; extends the applicability for-- of certain-- of criteria for eligibility of-- for assistance; harmonizes provisions; and repeals the original section. LB36, introduced by Senator DeBoer, is a bill for an act relating to revenue

LB38, introduced by Senator Blood, is a bill for an act relating to revenue and taxation; amends section 77-2716; provides an income tax adjustment related to federal retirement annuities; and repeals the original section. LB39, introduced by Senator Blood, is a bill for an act relating to the Legislature; states findings; provides for disability impact statements for legislation; and provides powers and duties for the office of Legislative Research. LB40, introduced by Senator Blood, is a bill for an act relating to agriculture; adopts the Riparian Protection and Water Quality Practices Act; and provides an operative date. LB41, introduced by Senator Hansen, is a bill for an act relating to the Administrative Procedure Act; amends section 84-920; prohibits state agencies from imposing annual filing and reporting requirements on charitable organizations as prescribed; states intent; defines a term; harmonizes provisions; and repeals the original section. LB42, introduced by Senator Hansen, is a bill for an act relating to children and families; amends several sections; defines and redefines terms; changes provisions relating to what constitutes child abuse and neglect under the Child Protection and Family Safety Act and the Nebraska Juvenile Code; changes grounds for juvenile court jurisdiction and termination of parental rights; harmonizes provisions; and repeals the original section. LB40-- excuse me LB43, introduced by Senator Sanders, is a bill for an act relating to the Administrative Procedure Act; amends section 84-920; requires hearing officers to interpret state agency rules and regulations de novo on the record; and requires courts and hearing officers to interpret statutes and regulations to limit agency power and maximize individual liberty; and repeals the original section. LB44, introduced by Senator Dungan, is a bill for an act relating to railroads; adopts the Midwest Interstate Passenger Rail Compact. LB45, introduced by Senator Dorn, is a bill for an act relating to cities and villages; creates the Revitalize Rural Nebraska Grant Program; provides powers and duties; creates a fund; and provides for fund transfers; and declares an emergency. LB46, introduced by Senator Dorn, is a bill for an act relating to appropriations; appropriates funds to the Department of Health and Human Services for a rate study. LB47, introduced by Senator Dorn. It's a bill for an act relating to the Open Meeting Act; amends section 84-1411; changes a public notice requirement relating to meetings by a rural fire, fire district or a suburban fire protection district; and repeals the original section.

CLERK: LB49, introduced by Senator Dungan, is a bill for an act relating to solar energy; amends several sections within Chapter 16 [SIC]; restates legislative findings; changes provisions relating to considerations for zoning regulations, ordinances, and comprehensive development plans; prohibits certain restrictions relating to solar energy collection and use; provides a cause of action; to harmonize provisions; provide severability; and repeals the original section. LB50, introduced by Senator Geist, is a bill for an act relating to criminal justice; amends several sections; changes provisions regarding problem solving courts, set asides, and restitution; defines terms; restates legislative intent regarding appropriations; creates pilot programs relating to courts, probation, and parole; terminates the Committee on Justice Reinvestment Oversight; provides duties for courts, the probation administrator, the Board of Parole, the Division of Parole Supervision, and the State Court Administrator; changes provisions relating to parole and provides for streamlined parole contracts; provides for applicability; harmonizes provisions; and repeals the original section. LB51, introduced by Senator Briese, is a bill for an act relating to state government; amends section 81-1120.27; changes provisions relating to the use of the state's telecommunications system; and repeals the original section. Over the last two years, I've had the privilege of meeting countless Nebraskans across our great state in their homes, at their farms and ranches, in their businesses and churches, and at lots of community gatherings in all 93 counties, most of them multiple times. And I can tell you with absolute certainty, wherever you travel, you won't find more innovative, more hardworking, and God-fearing people. I'm guilty. I love Nebraska. I think you all agree there is truly no place like it. Since the beginning, when pioneers settled the territory of Nebraska, our strength has come from our people, not from government. Our people bring their best every single day. We work to earn a good living, to do our jobs to the best of our ability, raise our family, look after our neighbors, and make things better for our grandkids. We all, we all do the hard work for keeping Nebraska great. Growing up, our family would make it to Lincoln maybe once a year. My brothers and I were always excited to see who could first see that Capitol coming in from the northwest. This Chamber and this building is, it's just amazing. It is just amazing. But I believe it's important for us all to remember that as incredible as this building and Chamber are, we don't look to this building for prosperity. Prosperity comes from the private sector: families, ranchers, business leaders who work hard, innovate and take risks. We don't look to government for our rights and freedoms. Those are innate, God-given by our God Almighty. And we don't want to be handed anything. We want to earn every bit of it. But we do expect that government does the-- does well in those limited functions that only it can perform. We expect low taxes, carefully controlled spending, transparency and accountability. We expect the business of the people to be handled like business. We expect good schools, quality roads, safe neighborhoods. We expect a government that promotes opportunity instead of limiting it. And we expect the leaders we elect to work together to find solutions to difficult challenges. You see, great people want limited government that respects their freedoms, does its job, and then gets the heck out of the way. Great people want the opportunity to succeed through grit and determination. Great people want to live and work around other great people, and they want the same for their children. That's why great people want to live right here in Nebraska. And the demand, the demand

for the good life is as strong as ever. But today, we have some obstacles to overcome. Too much of our talent leaves the state. Our broken tax code is burdensome and uncompetitive. It weighs on all Nebraskans, and it limits our state's economic potential. That's why we have to achieve transformational tax change now. Our state funding education formula is outdated and unfair to far too many of our students. State aid to education must be modernized so that it is more equitable, meeting the needs of our students in all across communities in Nebraska. All Nebraskans agree, we never, ever give up on kids. And we all agree that they are our future. We can never, ever, ever give up on our kids. Thank you. These are not easy feats to accomplish, and there will do-- be even more to do in this session. The question for all of us today is whether we can live up to the example set by us-- for us, by those we serve. Can we, can we live up to the example set by the-- set for us by those we serve? Whether we can come together and do the big, difficult things that require us to secure a more prosperous future. As I look to the One Hundred Eighth Nebraska Legislature, the answer is clear. We can do big things by working together. Together we can. Together we can and must build productive working relationships of trust and goodwill. Together we can and must achieve attitudinal change and not have our focus not on what's best for your community or mine, but to focus on what's best for the future of the entire state of Nebraska. Thank you. And together we can and must rise to meet any challenge, overcome any obstacle, and do the hard work of keeping Nebraska great for the generations to come. I'm here to do my part to bring my knowledge and experience to the table and to listen to all Nebraskans, to advocate for the values and interests of our citizens from the Missouri River to Harrison and everywhere in between, to hold our cabinet agencies to the highest standards of performance and expectations and treat-- and to treat our tax dollars as my own. My dad taught me that every nickel matters. We need to treat nickels like manhole covers, making decisions with fiscal conservatism and the constant drive to do more with less. I will work as a good-faith partner with my fellow constitutional officers, the Judiciary and the Legislature in doing the people's work. As we embark on a new chapter of Nebraska's history, I want to thank all of you for answering the call to public service. Also to thank your families and mine for being, for being there, supporting us, because we'll need their help to do the hard work that lies ahead. To thank-- thank you. And I also want to thank the brave men and women of our armed forces, law enforcement and first responders for all they do to keep us safe and
