14 <u>authorized and directed to draw his or her warrants upon the funds in the</u>

15 state treasury enumerated in this act, in favor of the several

18 several amounts appropriated in this act shall be in full payment of any

21 officers, agents, and employees, and their successors and assigns with

22 respect to each of the beneficiaries respectively in whose favor the
