

### Percentage by Service Area


Data includes youth with the following legal statuses: Office of Juvenile Services (OJS) and Department of Health and Human Services (DHHS) state wards; court supervision youth; youth who have been directly relinquished to the state as HHS state wards or OJS ward; non-court involved youth; youth in a police hold; youth in placement with DHHS and alternative response youth and families. The data extracted is from the N-FOCUS system. The number of children served is an unduplicated count.



### **Expenditures by Service Area**

The CFS budget is not allocated by service area. CFS provides expenditure data to show the proportion per service area. Data includes expenditures for state wards, voluntary cases, subsidized guardianships, former ward services, and independent living services. Data includes expenditures for services paid from N-FOCUS and payments made outside of N-FOCUS. Data does not include expenditures paid from Medicaid.

The chart shows the breakout by service area for Program 354, including Subprograms 30 and 48, and Program 345, including Subprogram 10. This data may not match Nebraska Information System (NIS) data due to refunds, cancellations, and/or other NIS payments that did not originate in N-FOCUS. Expenditure data for each Service Area does not include administrative costs such as staffing and office space.



### **Percentage by Service Area**



CFSS Trainees are in training status for the first six months of employment. The CFSS may have more than 1 degree and would be counted for each degree in the included data.



### b. Caseload per CFSS


The following chart illustrates the average caseload for CFSS Statewide and by Service Area. This measure includes all cases for Out-of-Home youth, In-Home families, Initial Assessment families, and Alternative Response families active on June 30, 2025. The measurement for these cases is the same as used for the caseload standard conformance: one report equals one case, one In-Home Family

equals on case, and one Out-of-Home Child equals one case. The chart below only includes CFSS and does not include supervisors, lead workers, or trainees who may have minimal cases assigned.



### c. CFSS per Child During SFY 2025

This measure includes all youth who were active CFS court-involved youth on June 30, 2025. For CFSS, the count includes the CFSS who conducted the Initial Assessment investigations within the past 12 months and the ongoing CFSS within the past 12 months. The count below is the average number of CFSS assigned to a child's case during the past 12 months, rather than a measure of case CFSS during the life of the child's case. Cases that do not progress beyond the initial assessment phase are excluded.




### d. CFSSs During the Past Seven Years

The following data utilizes June 30, 2025 as the endpoint to determine each time frame. CFSS case assignment data includes DHHS and Contracted Agency Staff from the last seven years. The count consists of the CFSS, which conducts the initial assessments and the ongoing casework. In many areas of the state, different CFSSs are assigned for the initial assessment and ongoing case work. In those

areas, a transfer from initial assessment to ongoing shows two CFSSs early in the life of the case. Other areas have the same CFSS conducting initial assessments and ongoing case management. Cases that do not progress beyond the initial assessment phase are excluded. This data includes the average number of CFSS per child's case for children in the child welfare system for three, six, twelve, and eighteen months, and the consecutive yearly average for children until the age of majority or permanency is attained.

For the Eastern Service Area, the CFSS count includes the CFSS conducting initial assessments and contracted agency staff providing ongoing case management through June 2022. Data after June 2022 does not include contracted staff.



### e. Monthly CFSS Turnover Rates

The data is expressed as a count and proportion of CFSSs that are no longer in the position from the prior month. Those not in the position may have been promoted, accepted a different position, or separated their employment from DHHS. Turnover rates in the charts below are limited to the CFSS position.










The chart below illustrates the percentage of consecutive monthly family team meetings by quarter documented in the N-FOCUS system.



### i. Monthly Consecutive Parent Contacts


The charts below illustrate the percentage of consecutive monthly contacts with mothers and fathers by quarter documented in the N-FOCUS system.






### j. Monthly Consecutive Child Contacts with CFSS

The chart below illustrates the percentage of consecutive monthly contacts with providers by quarter documented in the N-FOCUS system.




### m. Non-Court Involved Children






### Wards in Residential Treatment Settings by Age


### **Wards in Residential Treatment Settings by Gender**




### Wards in Residential Treatment Settings by Race/Ethnicity

- 10. Behavior and developmental disability needs






