LETTER FROM THE COMMISSION

On behalf of the Nebraska State Racing and Gaming Commission, I respectfully submit the Commission's 2025 Annual Report to the Governor.

This report summarizes the Commission's activities, regulatory actions, and oversight responsibilities during the reporting period. Our mission is to ensure compliance through education and effective regulation of the horse racing and casino industries in the State of Nebraska. We want to ensure all Racing and Gaming operators are successful while remaining in compliance with the statutory and regulatory framework created for them to operate within.

Throughout the year, the Commission carried out its statutory duties through the licensing and regulation of racing, gaming, and wagering activities; enforcement of applicable laws and rules; and coordination with industry participants and other stakeholders. These efforts supported a relatively new regulated industry, in place since 2022, that contributes to the state's economy while maintaining strong safeguards for the public interest.

During this period, the Commission focused on customizing a new licensing database and approved the opening of Nebraska's second permanent casino, Elite Casino and Resorts Grand Island, which includes the state's first poker room. The Commission also approved and oversaw the initial phases of two new racetracks located in South Sioux City and Ogallala, respectively. In addition, a new temporary gaming facility opened in Ogallala, along with Phase 2 of WarHorse Omaha. The information contained in this report reflects the Commission's commitment to transparency, accountability, and effective oversight.

The Commission appreciates the continued support of the Governor's Office and the Legislature, as well as the professionalism of Commission members and staff who carry out this work. Their hard work and due diligence are essential to maintaining a regulatory framework that balances economic activity with strong public protections.

The Commission remains committed to fulfilling its responsibilities with transparency, integrity, and consistency, and to adapting its regulatory approach as the racing and gaming landscape continues to evolve.

HISTORY & STATUTORY AUTHORITY

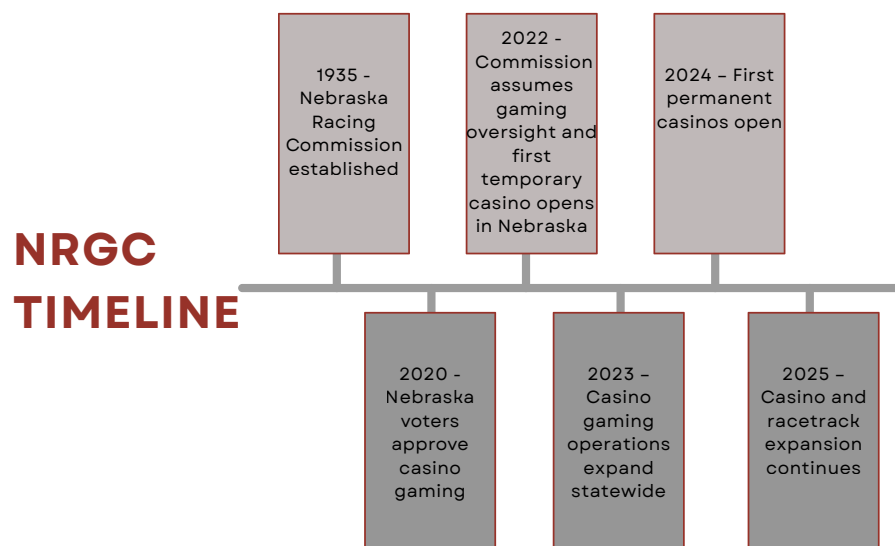
The Nebraska Racing and Gaming Commission was established in 1935 as the Nebraska State Racing Commission to regulate pari-mutuel horse racing in the State of Nebraska. For decades, horse racing was the Commission's sole regulatory focus, and agency operations, systems, and staffing were built entirely around racing oversight.

In 2020, Nebraska voters approved constitutional amendments authorizing casino gaming at licensed racetrack facilities. This voter approval expanded the Commission's authority and formally transitioned the agency into the Nebraska Racing and Gaming Commission, responsible for regulating both racing and casino gaming.

At the time casino gaming was authorized, Nebraska did not have an existing gaming regulatory framework. The Commission was required to develop licensing systems, compliance standards, investigative procedures, and enforcement processes from the ground up, while continuing to oversee racing operations statewide.

As casino gaming was implemented, the Commission oversaw the phased opening of licensed casino facilities across Nebraska, including both temporary and permanent operations. Certain facilities continue to progress toward permanent openings, subject to final approvals and construction timelines.

The Commission operates under statutory authority established in the Nebraska Revised Statutes governing horse racing, casino gaming, and sports wagering. This authority enables the Commission to license, investigate, audit, and enforce compliance while protecting the public interest and maintaining the integrity of Nebraska's regulated gaming industries.



HUMAN RESOURCES

In 2025, the Nebraska Racing and Gaming Commission supported an expanded regulatory scope for racing, casino gaming, and sports wagering by maintaining appropriate staffing levels and investing in employee training and development.

As of December 31, 2025, the Commission employed **41 staff**, including six Commissioners, supporting administrative, compliance, licensing, and enforcement functions statewide.

TRAINING & DEVELOPMENT

Employees recorded **793.54 training hours** in 2025, excluding investigator certification training. All staff completed required agency-wide training courses, and three members of Commission management completed the State of Nebraska Leadership Cohort.

HIRING ACTIVITY

The Commission onboarded **19 new hires** in 2025 across multiple employment categories.

An additional **three individuals** transferred to the Commission from another state agency during 2025.

INFORMATION TECHNOLOGY

In 2025, the Nebraska Racing and Gaming Commission's Information Technology function supported agency operations across headquarters and casino locations, with an emphasis on system reliability, regulatory technology, and secure access to Commission services.

IT OPERATIONS & SUPPORT

IT staff supported approximately **41 users** across Commission headquarters and five casino locations, completing roughly **400 IT support tickets** during the year. These efforts supported day-to-day agency operations, regulatory oversight, and expanded gaming activity statewide.

SYSTEMS & PLATFORM MODERNIZATION

At the end of 2025, the Commission launched ID Pair, a web-based platform for managing the Voluntary Self-Exclusion program and completed preparation for onboarding the Thentia licensing platform. Technology enhancements also included implementation of live streaming and video and audio recording for all Commission meetings, improving public access and record retention.

NETWORK & EXPANSION SUPPORT

The Information Technology staff member supported agency expansion by completing network installations at each permanent casino location and adding remote license application processing capabilities in advance of the new licensing database launch.

COMPLIANCE

In 2025, the Nebraska Racing and Gaming Commission’s Compliance Division continued oversight of gaming and racing operations statewide, with a focus on regulatory adherence, internal controls, and operational integrity across licensed facilities.

OVERSIGHT & AUDIT ACTIVITY

During the year, Compliance staff conducted **192 audits** across Nebraska’s casino and racetrack facilities, supporting oversight during periods of expansion and permanent openings. Audit activity resulted in documented findings, including **107 non-compliant findings, 21 compliant determinations, and 64 violation notices** or other findings, all of which were addressed through established regulatory processes.

TRAINING, COORDINATION & OUTREACH

Compliance staff also participated in and facilitated training and coordination activities throughout the year, including regulatory training, fingerprint training, and internal compliance training. Staff additionally supported **Human Trafficking and Problem Gambling roundtable** discussions in coordination with law enforcement, licensed gaming operators, responsible gaming organizations, and community and advocacy partners, supporting awareness and cross-agency collaboration. As casino operations expanded statewide, the Compliance Division supported several major milestones, including the permanent opening of Grand Island Casino Resort, the temporary opening of Lake Mac Casino Resort, and a second-phase rollout at WarHorse Omaha.

INVESTIGATIONS

In 2025, the Nebraska Racing and Gaming Commission's Investigations Division supported regulatory oversight across gaming, racing, and corporate licensing activities statewide, with a primary focus on background investigations and regulatory compliance. During the year, the Investigations Division handled **2,166 cases**, the majority of which involved background investigations required for licensing and regulatory approvals. Additional investigative activity included regulatory violations, criminal matters, and other investigations related to licensed operations.

REGULATORY VIOLATIONS & REFERRALS

All regulatory violations identified during investigations were formally referred for enforcement. Gaming-related violations were referred to Commission leadership, while racing-related violations were referred to the Stewards.

CRIMINAL MATTERS & DISPOSITIONS

Investigations resulted in three criminal referrals to county attorneys, including two cases in Platte County and one case in Hall County. One case resulted in successful prosecution, and two cases remained pending at the end of 2025. Referred criminal matters involved cheating, ticket-in/ticket-out (TITO) theft, and damage to a gaming device.



COORDINATION & TRAINING

Investigators coordinated with state, local, and federal law enforcement agencies, regulatory partners, and industry organizations throughout the year to support information sharing and effective oversight. Investigative staff also participated in specialized training related to corporate background investigations and supported national equine integrity efforts, including service on the equine integrity team at the Del Mar Breeders' Cup for a second consecutive year.

LICENSING OVERVIEW

Licensing supports all regulated gaming and racing operations statewide. The licensing division processed all license applications for gaming and racing personnel, vendors, corporate entities, and other regulated roles.

During 2025, the Commission reviewed and approved proposed changes to Title 294 and 296 of the Nebraska Administrative Code, including updates to licensing requirements and costs. While these Titles are under the review of the Attorney General's office, the Commission now maintains an updated schedule of all license types and fees on the agency website. Beginning January 1, 2026, all licenses will be issued for a three-year term, which will result in year-to-year variability in licensing volume and associated revenue across each three-year cycle. Legislation passed in 2025 also changed the window for required fingerprinting for racing applicants, changing it to three years to match the requirements for gaming applicants.

GAMING LICENSES

In 2025, the Nebraska Racing and Gaming Commission issued a total of **3,162 gaming licenses** across regulated gaming operations statewide. Licensing activity included occupational licenses, vendor and key person licenses, operator-related licenses, and parent or holding company licenses.

The Commission collected **\$706,785** in gaming licensing fees during 2025, including **\$1,685** for 68 replacement badges. In addition, the Commission collected **\$5,000,000** in annual Authorized Gaming Operator licensing fees, assessed at **\$1,000,000** per licensed gaming property.

RACING LICENSES

In 2025, the Nebraska Racing and Gaming Commission administered racing licensing in support of live race meets and regulated racing operations statewide. Racing licenses covered a wide range of roles, including owners, trainers, jockeys, officials, veterinarians, and track personnel.

During the year, the Commission issued a total of **1,510 racing licenses**. The Commission collected **\$58,765** in racing licensing fees in 2025, including **\$15,160** in fingerprint fees and **\$105** for duplicate licenses.

VOLUNTARY SELF-EXCLUSION PROGRAM

In 2025, the Nebraska Racing and Gaming Commission continued administration of the Voluntary Self-Exclusion (VSE) Program across licensed gaming operations statewide.

PROGRAM ADMINISTRATION

Program participation continued to increase during the year. The Commission processed new enrollments, updates, and removals, and maintained the statewide VSE list for use by licensed operators.

During the year, the Commission implemented ID Pair, a secure, web-based system used to manage VSE enrollments and updates. The system supports electronic submission, identity verification, and coordination with licensed operators, improving timeliness, consistency, and accessibility for individuals enrolling in the program.

VIOLATIONS & REMITTANCE

During 2025, a total of **77 VSE violations** were identified, resulting in **\$27,188.16** in remittance payments collected from licensed casinos. Remittance funds are directed toward problem gambling treatment, prevention, and education programs in Nebraska.



LAB TESTING & VETERINARY OVERSIGHT

In 2025, the Nebraska Racing and Gaming Commission continued to oversee laboratory testing and veterinary services in support of the integrity of live horse racing conducted in the state. Oversight activities focused on medication compliance, equine health and safety, and enforcement of racing rules at licensed race meets.

The Commission maintained its partnership with Industrial Laboratories in Denver, Colorado for the handling and processing of equine test samples. Veterinary oversight was provided at all live race meets held during the year. Laboratory results and veterinary findings were reviewed by Commission staff and, when applicable, referred through established regulatory and enforcement processes.

In addition, the Commission implemented a veterinary internship program in 2025 within the test barn, providing hands-on experience in equine care and regulatory testing processes, and designed to increase interest in equine veterinary practice, resulting in strong participation from veterinary students.

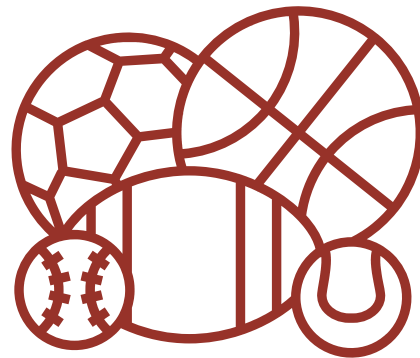
SPORTS WAGERING OVERSIGHT

In 2025, the Nebraska Racing and Gaming Commission provided regulatory oversight of licensed sports wagering operations statewide. Oversight activities focused on sportsbook catalog review, audit and compliance activity, and response to patron complaints across all licensed operators.

Sports wagering activity occurred at five licensed casino properties operated by three sportsbook platform providers. Kambi supported sportsbook operations at WarHorse Lincoln and WarHorse Omaha. Caesars Sportsbook operated at Harrah's Columbus, and IGT provided sportsbook platforms at Grand Island Casino Resort and Lake Mac Casino Resort.

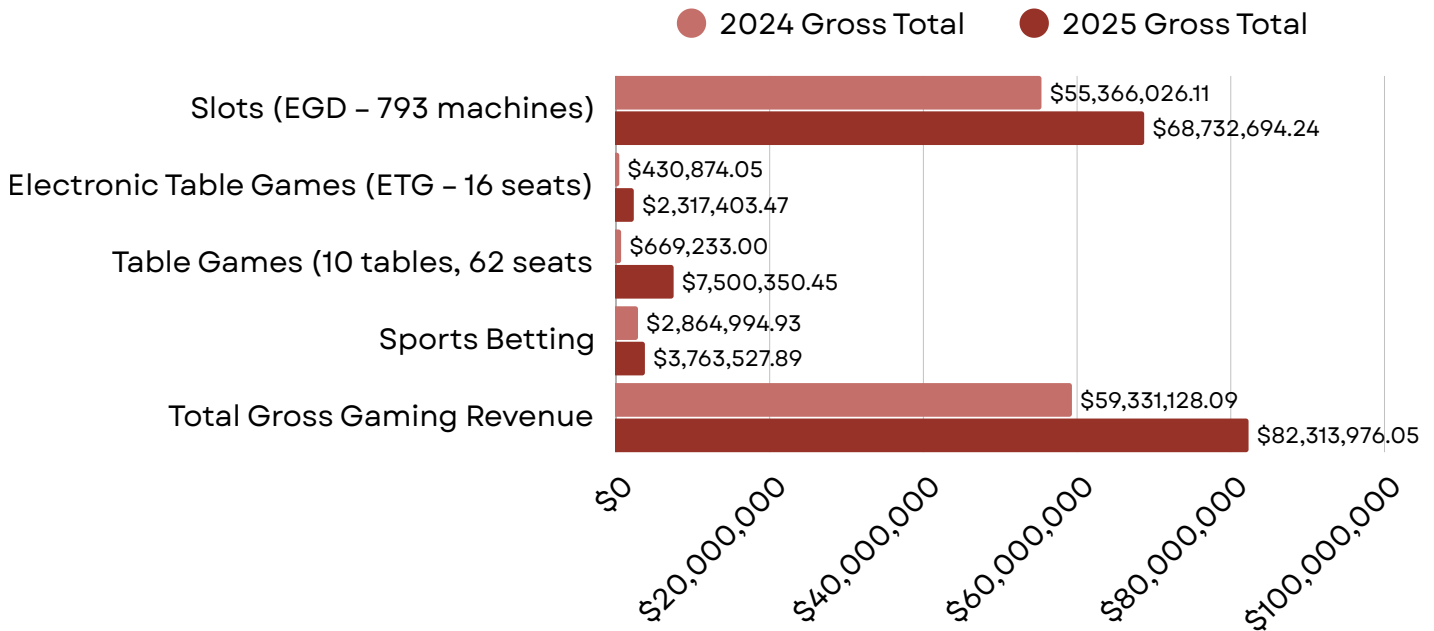

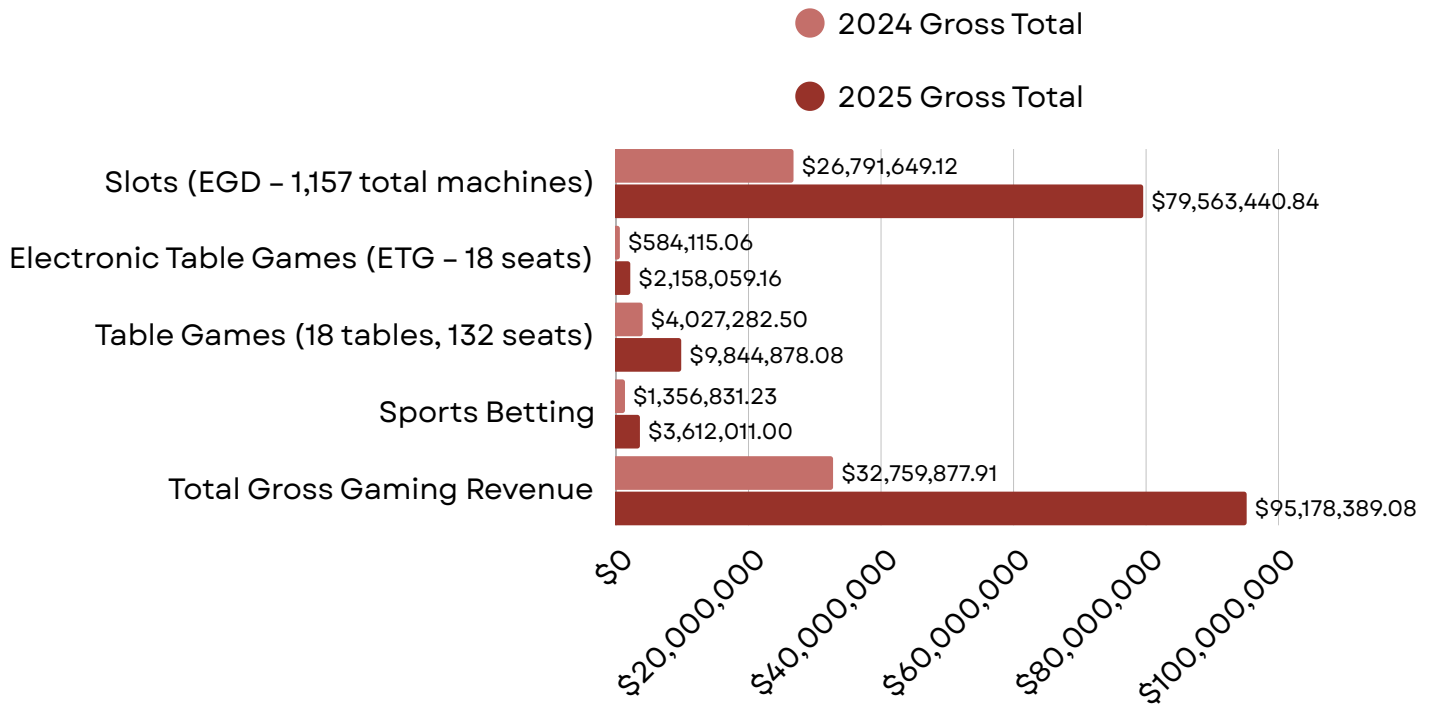

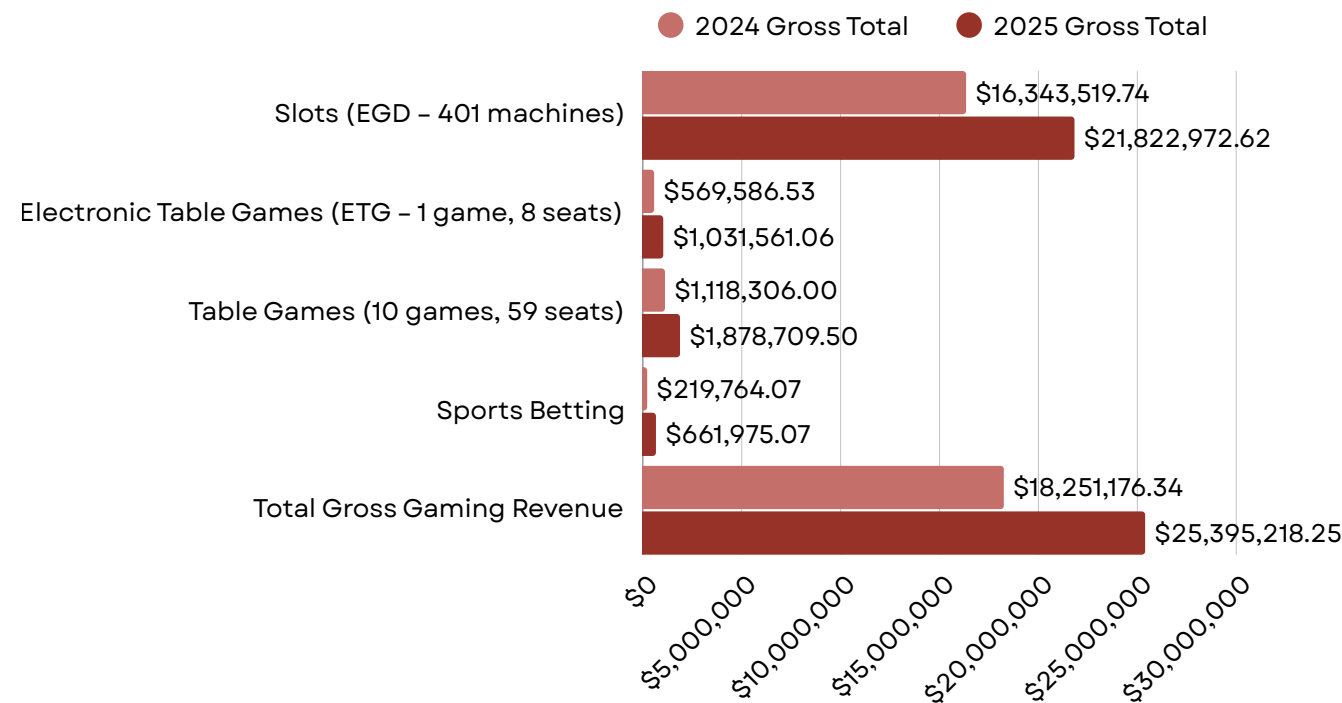

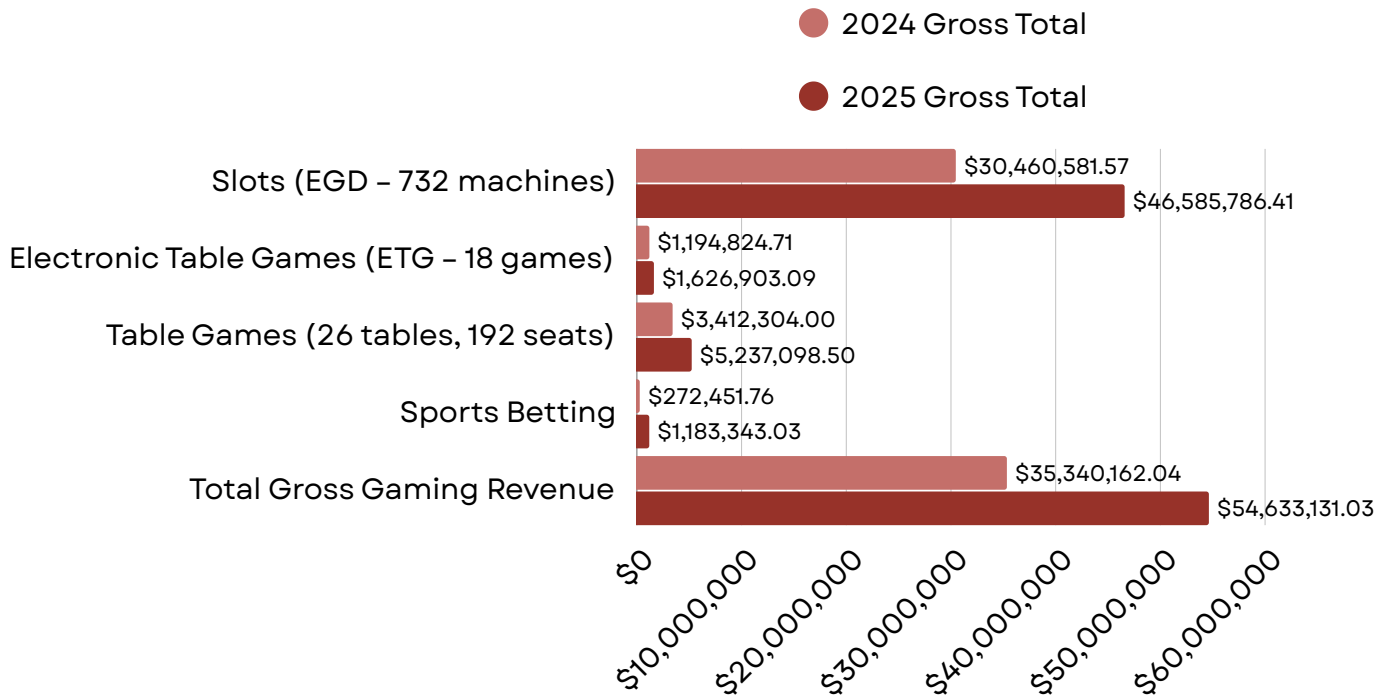

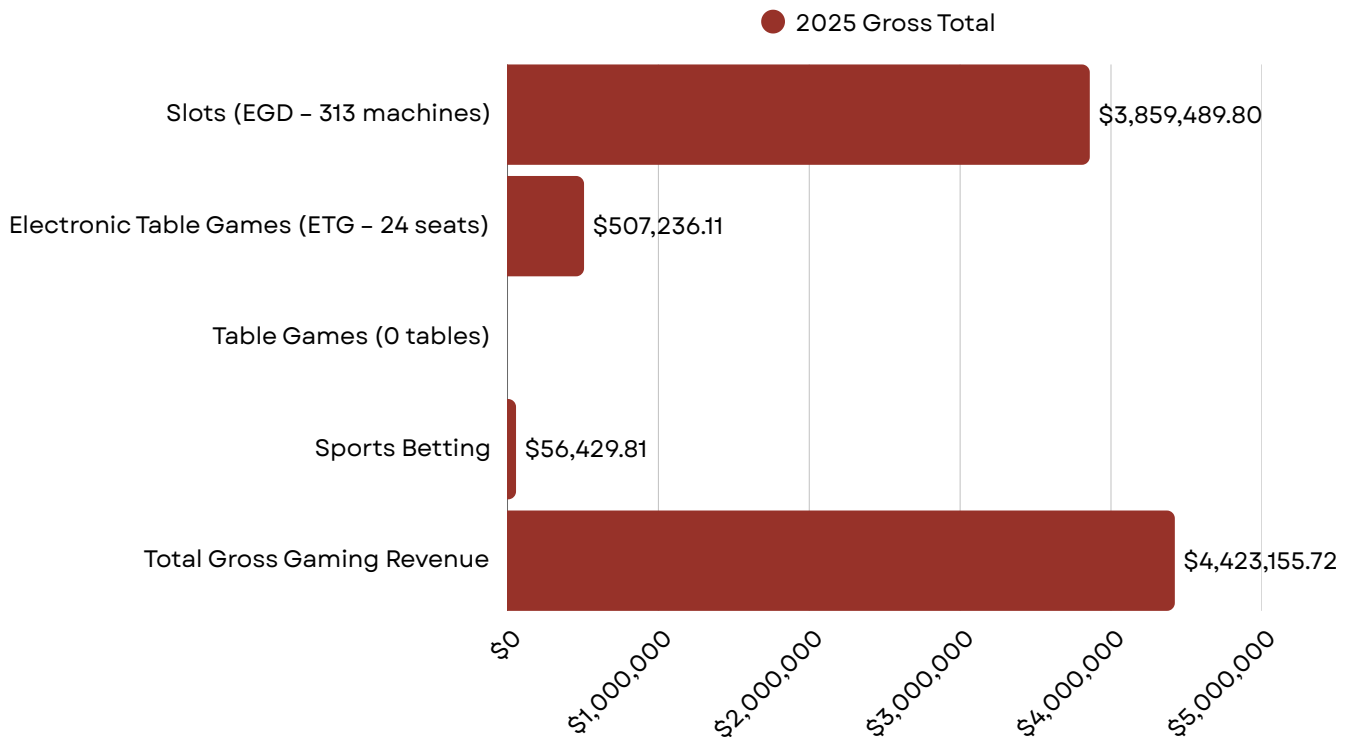

RACING & GAMING REVENUE SUMMARY

In 2025, total revenue across both gaming and racing increased compared to 2024. Gaming revenue growth was driven primarily by increased activity in slot and table game play. Racing revenue also increased year over year, with growth in both intrastate and interstate wagering totals.

In addition to gaming and racing activity, the Commission collected **\$200,000** in annual license review fees during 2025. The \$50,000 annual review fee was assessed to four casino properties that had been operating for more than one year. Lake Mac Casino Resort was not assessed an annual review fee in 2025 due to its August 19, 2025, opening date.

2025 Highlights: Total gross gaming revenue increased from **\$145.7 million (2024) to \$261.9 million (2025)**. Nebraska Racing and Gaming Commission racing revenue increased from **\$525,000 (2024) to \$818,875 (2025)**.

LOOKING AHEAD TO 2026

As we look toward 2026, I am optimistic about the opportunities ahead for the agency. Since 2022, the agency's efforts have appropriately been concentrated on supporting the industries we regulate through a period of significant growth and change. This has included the opening of multiple properties, expansion into additional phases of development, the introduction of racetracks, and the onboarding of a substantial number of new employees to meet regulatory demands.

At this time, there are no major industry expansion projects anticipated for 2026. This pause in large-scale development provides a valuable opportunity for the agency to focus inward and strengthen its internal operations. We view this as an important and necessary step to ensure the agency remains effective, efficient, and well positioned to meet future regulatory responsibilities.

In 2026, the agency will prioritize reviewing and revamping its mission and vision statements to ensure they accurately reflect our role, values, and long-term objectives. Additionally, we have identified several foundational projects that will be addressed to improve internal processes, consistency, and overall effectiveness. While these initiatives are internally focused, they are intended to ultimately benefit the industries we regulate through clearer expectations, standardized practices, and improved regulatory outcomes.

Our goal as an agency remains to provide effective oversight while recognizing the realities of the regulated industries as businesses. We want the industries we regulate to be successful and sustainable. Our responsibility is to educate, promote consistency and standardization, and ensure compliance through fair, thoughtful, and effective oversight.

This period of reflection and refinement will strengthen the agency and better position us to continue fulfilling our statutory responsibilities in the years ahead.
