Subject: Juvenile Room Confinement Report

Dear Mr. Metzler:

Neb. Rev. Stat. § 83-4,134.01 requires Nebraska's juvenile facilities to report quarterly regarding the use of room confinement in Nebraska's juvenile facilities.

Attached you will find the room confinement usage data for the Youth Rehabilitation and Treatment Centers (YRTC) in Hastings, Kearney, and Lincoln for the fourth quarter of fiscal year 2026. The YRTC system continues to use room confinement as a behavioral management tool for high-risk youth in our care. Efforts are continually made to guarantee youth are confined for the shortest time possible to ensure the safety of all parties.

The Whitehall Psychiatric Residential Treatment Facility (PRTF) in Lincoln did not use room confinement during the fourth quarter of FY2026. The facility is authorized to use room confinement, but has been able to employ de-escalation techniques to address behavioral concerns while providing a safe environment for youth and staff.
