- LB 10e (*Hughes*) Change requirements relating to wholesale drug distributors and dispensing of certain prescription drugs
- \* LB 21 (*Cavanaugh, J.*) Adopt the Uniform Unlawful Restrictions in Land Records Act
- LB 42 (*Riepe*) Provide for employment of nurse aides in intellectual and developmental disability facilities
- LB 59 (*Sanders*) Provide for the disbursement of funds of a natural resources district by electronic payment systems
- LB 98e (*Moser*) Redefine all-terrain vehicle and utility-type vehicle in the Motor Vehicle Certificate of Title Act, the Motor Vehicle Registration Act, and the Nebraska Rules of the Road
- LB 118 (*Hardin*) Change supervising authority for a pharmacist
- \* LB 139 (*Dungan*) Change provisions relating to the Real Property Appraiser Act and the Nebraska Appraisal Management Company Registration Act

- LB 180 (*Clouse*) Change requirements for public lettings and biddings and provide an exception for the Department of Natural Resources under the State Procurement Act
- \* LB 187e (*Dover*) Change provisions of the Nebraska Real Estate License Act
- LB 196 (*Storm*) Authorize the operation of all-terrain vehicles and utility-type vehicles between the hours of sunset and sunrise if used for snow removal
- LB 197 (*Storm*) Change provisions relating to disqualification for benefits, claim determinations, and claim redeterminations under the Employment Security Law
- \* LB 231 (*Hallstrom*) Adopt the Uniform Special Deposits Act
- LB 240e (*Jacobson*) Change certain notice provisions under the Community Development Law
- LB 250 (*Jacobson*) Change provisions relating to qualifications of the board of directors of a bank
- \* LB 251e (*Jacobson*) Adopt changes to federal law regarding banking and finance and change provisions regarding loan limits, branch banking, failing financial institutions, credit unions, surety bonds, and interest rates for damages payable to irrigation districts
- \* LB 296 (*Arch*) Require the State Department of Education to create a centralized education records system and employ registrars relating to students under the jurisdiction of the juvenile court and change provisions relating to graduation requirements and the State Department of Education Improvement Grant Fund

- LB 335 *(Conrad)* Redefine child under the In the Line of Duty Dependent Education Act

- \* LB 362 *(DeBoer)* Transfer and eliminate provisions of the Emergency Telephone Communications Systems Act and the Enhanced Wireless 911 Services Act and change provisions of the 911 Service System Act
- \* LB 609 *(Bostar)* Adopt the Controllable Electronic Record Fraud Prevention Act, require notice of potential fraud for purchasers of gift certificates and gift cards, and change provisions relating to search warrants
- LB 609A *(Bostar)* Appropriation Bill
- \* LB 229 *(Hallstrom)* Exclude marketplace network contractors working for marketplace network platforms from the Employment Security Law

- LB 248 *(Sanders)* Exempt certain programs from child care licensing requirements
- LB 105 *(Hughes)* Change procedures for voting or election precincts for public power districts
- LB 266 *(Dover)* Prohibit political subdivisions from enacting ordinances which have the effect of imposing rent controls on private property
- LB 135 *(Holdcroft)* Provide, change, and eliminate provisions relating to elections for certain purposes related to bonds and tax levies
- LB 529 *(Jacobson)* Provide certain exemptions relating to contracts for the Nebraska Investment Council under the State Procurement Act and the Taxpayer Transparency Act
- LB 326 *(Jacobson)* Change provisions relating to the Unfair Insurance Trade Practices Act, the Nebraska Property and Liability Insurance Guaranty Association Act, and mutual insurance holding companies and eliminate the provisions of the Health Insurance Access Act and the Health Care Purchasing Pool Act
- LB 457 *(Bostar)* Require anaphylaxis policies for school districts and licensed child care facilities and provide a limit on the amount an insured is required to pay by an insurance policy or benefit plan for epinephrine injectors
- LB 84 *(Rountree)* Adopt the School Psychologist Interstate Licensure Compact
- LB 355 *(Andersen)* Change provisions relating to census data used for certain tax and economic development programs
