### GENERAL FILE: CONSENT CALENDAR

The following rules apply to Consent Calendar:

- 1) If any five members of the Legislature object to the bill being considered on Consent Calendar, please advise the Clerk in writing. Such requests must be filed with the Clerk prior to the reading of the bill, at this stage of consideration, on the bill to be removed.
- 2) Upon either the completion of debate or the expiration of 15 minutes, whichever comes first, a vote shall be taken to advance the bill and on any pending motions or amendments pursuant to Rule 5, Section 6(d).
- 3) Any amendment adopted, other than the standing committee amendment, which adds new subject matter to the bill will result in the bill not being scheduled at the next stage of debate.

LB 90 *(Clouse)* Change provisions relating to improvement districts in cities of the first class

LB 183 *(DeKay)* Change provisions relating to the Uniform Disposition of Unclaimed Property Act

LB 635 *(Hansen)* Authorize the regulation of professional bare-knuckle mixed martial arts, professional mixed martial arts on ice, amateur kickboxing, and slap fighting by the State Athletic Commissioner

LB 519 *(Juarez)* Require independent confirmatory testing of potential items of contraband or drugs in prisons

LB 419 *(Lonowski)* Change provisions relating to admission to veterans homes and veterans aid
