## GENERAL FILE

LB 397 (*Moser*) Eliminate provisions relating to workplace safety committees and a workplace safety program and terminate a fund

LB 441 (*Spivey*) Authorize virtual inspections for certain building permits and require certain inspection records be made available to the public under the Building Construction Act

LB 353 (*Lonowski*) Allow public school employees to join or terminate membership in a labor organization

LB 794 (*DeKay*) Change powers and duties of the Department of Agriculture and eliminate provisions relating to the Healthy Soils Task Force and obsolete fund transfers

LB 717 (*Jacobson*) Adopt changes to federal law regarding banking and finance, change provisions relating to control of certain banks and trust companies, digital asset depository institutions, interest rates on certain loans, installment loans, mortgage loan originators, and mortgage bankers, and change references to the Nebraska Money Transmitters Act in the Controllable Electronic Record Fraud Prevention Act

LB 719 (*Jacobson*) Redefine a term under the Nebraska Rural Projects Act

LB 718 (*Jacobson*) Change provisions relating to examination, permit issuance, and disciplinary actions regarding certified public accountants

LB 60 (*Quick*) Eliminate the restriction on selling a lottery ticket through a vending or dispensing device under the State Lottery Act

LB 212 (*Wordekemper*) Require licensure of persons engaged in remote sales of covered tobacco products under the Tobacco Products Tax Act and provide for taxation of such sales

LB 207 (*von Gillern*) Provide a registration fee under the Motor Vehicle Registration Act for certain commercially registered alternative fuel vehicles

LB 384 (*Storer*) Require the county assessor and one voting member of the governing bodies of participating political subdivisions to attend joint public hearings under the Property Tax Request Act

LB 518 (*Juarez*) Change requirements for a report by the Department of Correctional Services and Board of Parole
