- LB 921 (*Ibach*) Adopt the Nebraska Worker Adjustment and Retraining Notification Act and change certain employer duties under the Non-English-Speaking Workers Protection Act

- LB 525 (*Jacobson, at the request of the Governor*) Adopt the Agricultural Data Privacy Act
- LB 1212 (*Riepe*) Provide for licensure of internationally trained physicians under the Uniform Credentialing Act

LB 815 *(Brandt)* Provide for a tax on diesel fuels, change provisions relating to refunds for motor fuel taxes and the petroleum release remedial action fee, change and eliminate provisions of the Ethanol Development Act, and eliminate the Ethanol Production Incentive Cash Fund
