Summary of purpose and/or changes:

LB 264, introduced by the Speaker at the request of the Governor, is a part of the Governor's biennial budget recommendations. LB 264 transfers funds, amends provisions related to funds, and outright repeals sections related to funds.

Explanation of amendments:

The amendment, AM835, becomes the bill. The amendment contains the Appropriations Committee's recommendation related to funds and statutory provisions to carry out the budget recommendations. The Appropriations Committee report "State of Nebraska FY 2025-26 and FY 2026-27 Biennial Budget, As Proposed by the Appropriations Committee 109th Legislature, First Session", published April 2025, contains a detailed discussion of the Committee recommendation.

Sections 1 to 85 contain transfers between various funds, as follows:

In section 110, the Nebraska Health Care Cash Fund is amended to change transfer amounts from the Nebraska Tobacco Settlement Trust Fund and to eliminate obsolete provisions.

In section 111, the Board of Educational Lands and Funds cash fund is amended to credit investment earnings to the fund beginning July 1, 2025.

In section 112, the Nebraska Capital Construction Fund is amended to authorize the crediting of investment earnings to the General Fund for FY26.

In section 113, the Capitol Restoration Cash Fund is amended to reflect transfers from the Unclaimed Property Trust Fund (LB 451).



In section 114, the administration authority of the Ferguson House Fund is amended to be used by the building division of the Department of Administrative Services.

In section 115, the Grade Crossing Protection Fund is amended to authorize transfers to the General Fund.

In section 116, the 211 Cash Fund is amended to authorize transfers to the General Fund.

In section 117, the Nebraska Appraisal Management Company Fund is amended to authorize transfers to the General Fund.

In section 151, provisions related to the federal Coronavirus Capital Projects Funds are amended to eliminate provisions related to the Nebraska Broadband Bridge Act.

In section 152, the Community College State Dependents Fund is amended to authorize transfers to the General Fund.

In section 153, the Nebraska Environmental Trust Fund is amended to authorize transfers to the Nebraska Soil and Water Conservation Fund and the Water Sustainability Fund.

In section 154, the Support Nebraska History Fund is amended to authorize transfers to the General Fund.

In section 155, the Prison Overcrowding Contingency Fund is amended to authorize transfers to the General Fund.

In section 156, the Cash Reserve Fund is amended to eliminate obsolete transfer provisions and to transfer \$45,897,000 from the fund to the Nebraska Capital Construction Fund in FY26, \$100,000 from the fund to the Self-Insured Liability Fund in FY25, and to state intent to transfer funds as necessary for distribution beginning in FY28 to the Nebraska Transformational Project Fund.

In section 157, provisions related to crediting of investment earnings on several funds are amended beginning July 1, 2025.

In section 158, the Private Postsecondary Career Schools Cash Fund is amended to authorize transfers to the Education Future Fund.

In section 159, the Tuition Recovery Cash Fund is amended to authorize transfers to the Education Future Fund.

In section 160, the Community College Gap Assistance Program Fund is amended to authorize transfers to the Education Future Fund.

In section 161, the Nebraska Telecommunications Universal Service Fund is amended to credit all investments earnings to the General Fund through FY2028-29 and eliminate provisions related to transfers to the 211 Cash Fund.

In section 162, the 911 Service System Fund is amended to credit investment earnings to the General Fund.



Section 163 contains an operative date for the sections related to the Ferguson House Fund.

Section 164 and 165 repeal the original sections of the statutes amended by the bill.

Section 166 outright repeals the Nebraska Nonprofit Security Grant Program Act (81-829.06 to 81-829.11); the Customized Job Training Act (81-1214, 81-1215, 81-1217, 81-1218, and 81-1219); the small business grant program (81-12,234 to 81-12,237); and obsolete provisions related to the Economic Recovery Act (81-12,144).

Section 167 is the emergency clause.

The following bill is incorporated into AM835:

LB 451 (Prokop) – The bill transfers money from the Unclaimed Property Trust Fund to the Capitol Restoration Cash Fund. The Committee amended the original bill to change the dates of the transfers to begin in 2026 and end in 2035. The bill, as amended, transfers the first \$1 million in the Unclaimed Property Trust Fund each year to the Capitol Restoration Cash Fund on November 1 of each year, beginning in 2026 until 2035. The bill provides that the remaining funds are transferred to the permanent school fund. The provisions of LB451 are contained in sections 107 and 113 of AM835.
