LB213 amends §79-760.01 to require the State Board of Education to adopt academic content standards on human embryology under the current science education standards.

On or before March 1, 2026, the board will adopt measurable academic content standards for human embryology under the science education standards. These standards will be integrated into every school's curriculum no later than the start of the 2026-27 school year.

**FISCAL IMPACT:**

The Nebraska Department of Education (NDE) would need to assemble subject area experts to determine the most appropriate level of detail for each grade. The estimated cost of that assembly is \$10,000 to update the standards, guidance creation, & professional development for teachers.

**Explanation of Estimate:**

Anytime the Department of Education is required to adjust standards, stakeholders are brought together to draft and properly situate content within the pre-existing set of standards. In the case of the proposed bill, the NDE would assemble subject area experts to determine the most appropriate level of detail for each grade. The NDE anticipates a cost of \$10,000 for the standards adjustment, guidance creation, and professional development for teachers. Additional costs would be incurred for local districts in the purchasing of additional instructional materials.
