Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill appropriates \$500,000 from the Health and Human Services Cash Fund in FY26 and FY27 to the Department of Health and Human Services (DHHS) Program 514, Public Health Aid, for state aid to a 501(c)(3) designated nonprofit that provides health care screening, sports competitions, educational opportunities, and leadership training to people with developmental or intellectual disabilities.

Note that the specified cash fund would not be able to sustain the appropriations without provision of additional funds.

Explanation of Estimate:

LB284 appropriates \$500,000 cash funds from the Health and Human Services Cash Fund to the Department of Health and Human Services (DHHS) to support Special Olympics programs in Nebraska. The bill does not add new funds to the Health and Human Services Cash Fund, and the existing funds are currently obligated to other programs and services within DHHS.

If an associated “A” Bill for LB284 is passed to appropriate the funds, \$500,000 would be added to the existing cash authority in Program 514 – Health Aid. Funding is to be used to award a grant to a non-profit organization that provides specific services for developmentally or intellectually disabled individuals.
