Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB528 amends §79-1054 to change provisions relating to grants funded from the Nebraska Department of Education (NDE) Improvement Grant Fund & to provide powers & duties to the Department of Economic Development (DED) relating to grants for learning platforms.

DED will take over the oversight from NDE pertaining to establishing a grant program to procure or purchase an annual license for a preexisting learning platform to be used in schools to engage students in coursework & careers in science, technology, & engineering.

A grant application approved by the DED will be awarded from the Nebraska Department of Education Improvement Grant Fund administered by NDE.

The learning platform will be designed to teach information related to chemistry, physical science, or mathematics & will align with the academic content standards established by the State Board of Education relating to high school chemistry or physical science & the equivalent of those standards used for middle school education & complies with the ISO 27001 data security standards.

Grant funds will only be used to procure or purchase an annual license & will not be awarded for the purpose of research & development of a learning platform.

FISCAL IMPACT:

The ending fund balance for FY23-24 was \$3,237,225.

The Appropriations Committee has included a transfer of \$1,700,000 in FY2025-26 from the State Department of Education Improvement Grant Fund to the Education Future Fund. This transfer could affect the amount of funding available for DED to use.

DED estimates the need for 0.5 of an FTE for FY2025-26 & 0.25 of an FTE for FY2026-27 to research the education standards, create & review applications, award & monitor the grant, & compile & prepare the required reporting. For FY2025-26, the FTE will have a salary/benefit expense of \$44,900; operating costs of \$9,870; & travel expenses of \$3,330. For FY2026-27, the FTE will have a salary/benefit expense of \$22,450; operating costs of \$5,720; & travel expenses of \$1,750.

Explanation of Estimate:

LB528 would reassign the responsibilities for a grant program from the State Board of Education to the Department of Economic Development. Grant awards will be paid from funds the State Department of Education Improvement Grant Fund administered by the State Department of Education.

The purpose of the grant is to procure or purchase annual licenses for an existing learning platform for use in schools to engage students in coursework and careers in science, technology and engineering. Potential developers would apply to DED to provide a learning platform that

- Designed to teach information related to chemistry, physical science or mathematics
- Aligns with State Board of Education standards
- Connect standards with real-world technologies and applications
- Highlights science, technology and engineering career pathways in Nebraska
- Complies with ISO 27001 data security standards
- Demonstrates experience with statewide implementation of a learning platform

Assuming that the program will require an RFP for awarding the grant, and one awardee, DED estimates that this will require the services of ½ an FTE of an Economic Development Business Consultant II to research the education standards, create and review applications, award and monitor the grant and compile and prepare required reporting. DED estimates that approximately \$2,460,000 and \$2,413,000 will be available for the program in FY2025-26 and FY2026-27, respectively. Operating costs also include \$8,500 annually for software licenses for the Department's grant management software.

Technical Note: The starting date for DED's involvement in the grant program is January 1, 2024, and annual reporting is due on July 1 each year beginning in 2024. The operative date for LB528 is assumed to be October 1, 2025. In addition, the grant program is to be funded from a Department of Education cash fund, which makes it difficult for DED to monitor spending and account balances in the state accounting system as DED would not have access to other agency's reports.
