LB754 amends Neb. Rev. Stat. §§ 28-1229 and 28-1239.01. It updates the Nebraska State Patrol explosives permitting provisions by setting the permit term at two years, and it updates the State Fire Marshal’s display fireworks permit application requirements by requiring proof of an NSP permit for the use of explosive materials. The bill retains the \$100 display permit fee credited to the State Fire Marshal Cash Fund.
