Specifically, it establishes a process where a defendant in a civil lawsuit can have direct negligence claims dismissed if they stipulate certain conditions regarding their employment relationship with the driver involved in the incident.

The Supreme Court states that there will be a minimal fiscal impact from LB 79, but no additional resources are required.
