AM1814 replaces the original provisions of LB816 and creates sections 1–4 to establish a peer support framework for public safety personnel. It allows public safety agencies to create peer support teams and requires written guidelines if a team is established. The amendment makes peer support communications and related records confidential and privileged, generally not subject to public records requests, discovery, or admission in proceedings, with limited exceptions such as consent, certain safety-related disclosures, and required reporting for child abuse/neglect and vulnerable adult abuse/neglect/exploitation.
