This bill adopts the School Psychologist Interstate Licensure Compact for a licensing pathway to create reciprocity among participant states. Additional work would be required by the Department of Health and Human Services (DHHS) within Program 178 – Professional Licensure however the costs would be recouped through newly assessed fees. Minimal fiscal impact to DHHS.

Applicants under the Compact, school psychologists from other states, would be subject to criminal background check by Nebraska State Patrol. The current rate for a criminal background check by fingerprinting is \$45.25. If required, the fee would be paid by the applicant. There is no fiscal impact to NSP.
