Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill establishes the Safe Parks and Public Spaces Act.

The bill provides definitions and creates a new Class V misdemeanor for knowingly or intentionally camping on public property or right-of-ways. The misdemeanor would apply to any infractions subsequent to an individual's first offense. Upon an individual's first offense of the law enforcement officer is obligated to direct the person to the nearest appropriate homeless shelter. There may be increased costs to courts due to the creation of a new crime however the impact is indeterminable.

The bill prevents political subdivisions from camping on public property or right-of-ways or preventing law enforcement officers to issue misdemeanors subject to the Act.

The bill permits civil action pursuant to the Act, including that by the Attorney General, against a political subdivision. If the political subdivision is found to have violated the prohibition on discouraging law enforcement from enforcing the act then the State Treasurer is required to be notified and required to suspend state fund payments to said political subdivision. Noncompliance for over six months shall result in state fund forfeiture.

There is no fiscal impact to the either the Nebraska Attorney General or State Treasurer. The Department of Health and Human Services indicates the need for one FTE to implement the provisions of the bill, which would require General Funds. There is no basis upon which to disagree with this estimate.

Explanation of Estimate:

LB925 proposes to create the Safe Parks and Public Spaces Act, intended to protect the public from the dangers of unauthorized street camping in public parks, right-of-way, and other public spaces by prohibiting unauthorized street camping. Various sections of the bill outline what systems need to be implemented for allowing the public to report violations, expected behavior of political subdivisions in the enforcement of the Act, and the proper remedies that may be sought in the case that a political subdivision fails to comply with the Act.

A new FTE Program Specialist will need to be hired to perform the new work associated with the legislation, and the current website for the DHHS Investigations Office will need to be updated to allow for submission of complaints related to the legislation. The estimated cost of hiring a new FTE Program Specialist would be \$64,400 in the first year and \$90,160 in the second year.

There is potential for an unknown amount of revenue to be collected from political subdivisions who forfeit their state funds. These funds would be added to the State's General Fund.
