- 1 A BILL FOR AN ACT relating to appropriations; to amend section 21,
- 2 Legislative Bill 261, One Hundred Ninth Legislature, First Session,
- 3 2025; to appropriate funds to aid in carrying out the provisions of
- 4 Legislative Bill 298, One Hundred Ninth Legislature, First Session,
- 5 2025; to change an appropriation; to repeal the original section;
- 6 and to declare an emergency.
- 7 Be it enacted by the people of the State of Nebraska,

1 **Section 1.** There is hereby appropriated (1) \$680,000 from the
2 General Fund for FY2025-26 and (2) \$680,000 from the General Fund for
3 FY2026-27 to the Legislative Council, for Program 129, to aid in carrying
4 out the provisions of Legislative Bill 298, One Hundred Ninth
5 Legislature, First Session, 2025.

6 Total expenditures for permanent and temporary salaries and per
7 diems from funds appropriated in this section shall not exceed \$590,500
8 for FY2025-26 or \$615,700 for FY2026-27.
