A BILL FOR AN ACT relating to insurance; to amend sections 44-32,180 and
 44-4726, Reissue Revised Statutes of Nebraska, and section 77-908,
 Revised Statutes Cumulative Supplement, 2024; to adopt the Medicaid
 Access and Quality Act; to change provisions relating to taxes on
 health maintenance organizations, prepaid limited health service
 organizations, and insurance companies; to repeal the original
 sections; and to declare an emergency.

8 Be it enacted by the people of the State of Nebraska,

Section 1. Sections 1 to 8 of this act shall be known and may be 1 2 cited as the Medicaid Access and Quality Act. 3 **Sec. 2.** The Legislature finds and declares that: (1) Wide discrepancies between medicaid reimbursement rates and 4 rates of other payers have created challenges to health care access for 5 6 Nebraska residents covered by medicaid; 7 (2) Approximately one-third of pregnant women, newborns, and children are covered by medicaid and access to health care services is 8 9 critical for them. Access to labor and delivery services is critical to 10 fostering healthy mothers and babies; (3) Access to primary care is vital to the health of Nebraska 11 communities. Investment in preventative care will help reduce future 12 health care costs to the state and its residents. Improved health 13 outcomes are more likely when patients have access to, and positive 14 15 relationships with, their primary care provider; (4) Health care access challenges in rural areas have reached a 16 17 critical point, which requires bold investment and leadership from the state to maintain the health of our rural citizens and communities; and 18 (5) Investment in physical health care access and quality in the 19 medicaid program is an investment in bolstering Nebraska's health care 20 21 landscape as a whole, addressing health care deserts across the state, 22 and improving the health and prosperity of Nebraska communities. Sec. 3. For purposes of the Medicaid Access and Quality Act: 23 24 (1) Nonhospital provider means a provider of physical health 25 services that does not hold a license as a hospital under the Health Care 26 Facility Licensure Act; 27 (2) Physical health services means services billed under the medicaid practitioner fee schedule to meet the physical health needs of a 28 patient; and 29

30 (3) Rural means any county in Nebraska having a population of less
 31 than one hundred thousand residents.

9 44-4726 (1) The same taxes provided for in section 44-32,180 shall 10 be imposed upon each prepaid limited health service organization, and 11 such organizations also shall be entitled to the same tax deductions, 12 reductions, abatements, and credits that health maintenance organizations 13 are entitled to receive.

Sec. 11. Section 77-908, Revised Statutes Cumulative Supplement,
2024, is amended to read:

77-908 (1) Every insurance company organized under the stock, 19 mutual, assessment, or reciprocal plan, except fraternal benefit 20 societies, which is transacting business in this state shall, on or 21 22 before March 1 of each year, pay a tax to the director of one percent of the gross amount of direct writing premiums received by it during the 23 24 preceding calendar year for business done in this state, except that (a) 25 (1) for group sickness and accident insurance the rate of such tax shall be five-tenths of one percent, (b) and (2) for property and casualty 26 insurance, excluding individual sickness and accident insurance, the rate 27 of such tax shall be one percent, and (c) for health maintenance 28 organizations subject to the Health Maintenance Organization Act, the tax 29 levied by section 4 of this act shall be in addition to the tax paid 30 under this section. 31

1 (2) A captive insurer authorized under the Captive Insurers Act that 2 is transacting business in this state shall, on or before March 1 of each 3 year, pay to the director a tax of one-fourth of one percent of the gross 4 amount of direct writing premiums received by such insurer during the 5 preceding calendar year for business transacted in the state.

(3) The taxable premiums shall include premiums paid on the lives of 6 persons residing in this state and premiums paid for risks located in 7 this state whether the insurance was written in this state or not, 8 9 including that portion of a group premium paid which represents the premium for insurance on Nebraska residents or risks located in Nebraska 10 included within the group when the number of lives in the group exceeds 11 five hundred. The tax shall also apply to premiums received by domestic 12 13 companies for insurance written on individuals residing outside this state or risks located outside this state if no comparable tax is paid by 14 the direct writing domestic company to any other appropriate taxing 15 authority. Companies whose scheme of operation contemplates the return of 16 a portion of premiums to policyholders, without such policyholders being 17 claimants under the terms of their policies, may deduct such return 18 premiums or dividends from their gross premiums for the purpose of tax 19 calculations. Any such insurance company shall receive a credit on the 20 tax imposed, except the tax paid under subdivision (1)(c) of this 21 section, as provided in the Creating High Impact Economic Futures Act, 22 the Nebraska Job Creation and Mainstreet Revitalization Act, the New 23 24 Markets Job Growth Investment Act, the Nebraska Higher Blend Tax Credit Act, the Relocation Incentive Act, the Sustainable Aviation Fuel Tax 25 Credit Act, the Nebraska Shortline Rail Modernization Act, and the 26 Affordable Housing Tax Credit Act. 27

Sec. 12. Original sections 44-32,180 and 44-4726, Reissue Revised
Statutes of Nebraska, and section 77-908, Revised Statutes Cumulative
Supplement, 2024, are repealed.
