- 3 Be it enacted by the people of the State of Nebraska,

Section 1. (1) The Infrastructure Review Task Force is created.

- 2 <u>(2) The task force shall:</u>
- 3 (a) Review and analyze Nebraska's transportation infrastructure
- 4 network;
- 5 (b) Examine and consider Nebraska's historic transportation
- 6 infrastructure development efforts and expected future transportation
- 7 infrastructure needs;
- 8 <u>(c) Utilize information and research available from the annual</u>
- 9 report on the needs of the state highway system prepared by the
- 10 <u>Department of Transportation and any other information or resources</u>
- 11 <u>available to the department;</u>
- 12 <u>(d) Examine the status and condition of Nebraska's transportation</u>
- 13 infrastructure with consideration given to highway safety concerns and
- 14 <u>make recommendations as to how Nebraska might maintain and ensure safe</u>
- 15 transportation infrastructure now and in the future;
- 16 (e) Consider transportation through the lens of its economic impact
- 17 on Nebraska; and
- 18 (f) Research any federal funding that may be available to Nebraska
- 19 <u>and make recommendations as to how Nebraska might obtain and use such</u>
- 20 <u>funds</u>.
- 21 (3)(a) The task force consists of the following members:
- 22 (i) The Governor;
- 23 (ii) A designee of the Governor;
- 24 (iii) The chairperson of the Revenue Committee of the Legislature;
- 25 (iv) The chairperson of the Transportation and Telecommunications
- 26 Committee of the Legislature;
- 27 (v) The Speaker of the Legislature;
- 28 (vi) The Director-State Engineer;
- 29 <u>(vii) The Tax Commissioner; and</u>
- 30 (viii) Three members of the Legislature appointed by the Executive
- 31 Board of the Legislative Council.

1 (b) Members of the task force who are not members of the Legislature

- 2 <u>shall be nonvoting, ex officio members.</u>
- 3 (4) The chairperson of the task force shall be the chairperson of
- 4 the Revenue Committee of the Legislature. Any staff support needed for
- 5 <u>the task force shall be fulfilled by the staff of the Revenue Committee</u>
- 6 of the Legislature.
- 7 (5) The members of the task force shall serve on the task force
- 8 <u>without compensation</u>.
- 9 (6) On or before December 1 of each year, the task force shall
- 10 <u>submit a report containing the results of its work study and its</u>
- 11 recommendations, if any, together with drafts of legislation necessary to
- 12 <u>carry out its recommendations. The reports shall be submitted</u>
- 13 <u>electronically to the Clerk of the Legislature.</u>
