1 A BILL FOR AN ACT relating to the Secretary of State; to amend sections
2 52-1001, 52-1003, 52-1312, 52-1313, and 52-1602, Reissue Revised
3 Statutes of Nebraska, sections 33-101 and 77-3903, Revised Statutes
4 Cumulative Supplement, 2024, and sections 9-523 and 9-525, Uniform
5 Commercial Code, Reissue Revised Statutes of Nebraska; to change and
6 eliminate provisions relating to fees, notices of liens under the
7 Uniform Federal Lien Registration Act and the Uniform State Tax Lien
8 Registration and Enforcement Act, the central filing system,
9 effective financing statements, the master lien list, and filed
10 records under the Uniform Commercial Code; to harmonize provisions;
11 to repeal the original sections; and to outright repeal section
12 52-1313.01, Reissue Revised Statutes of Nebraska.

13 Be it enacted by the people of the State of Nebraska,

1 **Section 1.** Section 33-101, Revised Statutes Cumulative Supplement,
2 2024, is amended to read:

3 33-101 There shall be paid to the Secretary of State the following
4 fees:

5 (1) For requesting a certificate or exemplification with seal, a
6 nonrefundable fee of ten dollars;

7 (2) For copies of records, for each page, a fee of one dollar;

8 (3) For accessing business entity records by electronic means:

9 (a) For batch requests of business entity information, fifteen
10 dollars for up to one thousand business entities accessed and an
11 additional fifteen dollars for each additional one thousand business
12 entities accessed over one thousand;

13 ~~(b) For information in the Secretary of State's Uniform Commercial~~
14 ~~Code Division database, including records filed pursuant to the Uniform~~
15 ~~Commercial Code, Chapter 52, article 2, 5, 7, 9, 10, 11, 12, or 14,~~
16 ~~Chapter 54, article 2, or the Uniform State Tax Lien Registration and~~
17 ~~Enforcement Act, for batch requests searched by debtor location, fifteen~~

26 electronic images, three hundred dollars weekly subscription rate, one
27 thousand dollars monthly subscription rate for a twice-monthly service,

30 Internet ~~or by other electronic means other than facsimile machine,~~

13 ~~(b) Effective financing statement data accessed through bulk data~~
14 ~~requests shall be for informational purposes only and shall not provide~~
15 ~~the protection afforded a buyer registered pursuant to section 52-1312;~~

16 ~~(5) For images of Uniform Commercial Code database information~~
17 ~~records accessed over the Internet, forty-five cents for each page or~~
18 ~~image of a page;~~

19 ~~(4) For taking acknowledgment, ten dollars;~~

20 ~~(5) For administering oath, ten dollars;~~

21 (6) For filings by for-profit corporations and associations required
22 or permitted by law to file articles of incorporation or organization
23 with the Secretary of State, the fees provided in section 21-205 unless
24 otherwise specifically provided by law; and

25 (7) For filings by nonprofit corporations and associations required
26 or permitted by law to file articles of incorporation or organization
27 with the Secretary of State or for such a filing by any entity declared
28 to be a corporation under section 21-608, the fees provided in section
29 21-1905 unless otherwise specifically provided by law.

30 The Secretary of State shall remit all fees collected pursuant to
31 subdivisions (1), (2), and (4) through (7) of this section to the State

1 Treasurer for credit to the Secretary of State Cash Fund. The Secretary
2 of State shall remit all fees collected pursuant to subdivision (3) of
3 this section to the State Treasurer for credit to the Records Management
4 Cash Fund, and such fees shall be distributed as provided in any
5 agreements between the State Records Board and the Secretary of State.

6 **Sec. 2.** Section 52-1001, Reissue Revised Statutes of Nebraska, is
7 amended to read:

8 52-1001 (1) Notices of liens upon real property for obligations
9 payable to the United States and certificates and notices affecting the
10 liens shall be presented in the office of the Secretary of State and may
11 be presented by electronic means. Such notices of liens and certificates
12 and notices affecting the liens shall be provided ~~transmitted~~ by the
13 Secretary of State to and filed in the office of the register of deeds by
14 the register of deeds of the county or counties in which the real
15 property subject to the lien is situated as designated in the notice of
16 lien or certificate or notice affecting the lien. A lien subject to this
17 subsection shall be effective upon real property when filed by the
18 register of deeds as provided in this subsection.

19 (2) Notices of federal liens upon personal property, whether
20 tangible or intangible, for obligations payable to the United States and
21 certificates and notices affecting the liens shall be filed in the office
22 of the Secretary of State and may be filed by electronic means.

23 **Sec. 3.** Section 52-1003, Reissue Revised Statutes of Nebraska, is
24 amended to read:

25 52-1003 (1)(a) If a notice of federal lien upon real property, a
26 refiling of a notice of federal lien upon real property, or a notice of
27 revocation of any certificate described in subdivision (2)(a) of this
28 section is provided ~~transmitted~~ to the register of deeds, he or she shall
29 endorse thereon his or her identification and the date and time of
30 receipt and forthwith file it alphabetically or enter it in an
31 alphabetical index showing the name and address of the person named in

1 the notice, the date and time of receipt, the serial number of the
2 district director or title and address of the official or entity
3 certifying the lien, and the total amount appearing on the notice of
4 lien.

5 (b) If a notice of federal lien upon personal property, a refileing
6 of a notice of federal lien upon personal property, or a notice of
7 revocation of any certificate described in subdivision (2)(b) of this
8 section is filed in the office of the Secretary of State, he or she shall

25 as specified in subsection (2) of section 52-1001, he or she shall file

30 (3)(a) Upon request of any person, the register of deeds shall issue
31 his or her certificate showing whether there is on file, on the date and

1 hour stated therein, any notice of lien or certificate or notice
2 affecting any lien, filed under the Uniform Federal Tax Lien Registration
3 Act on or after January 1, 1970, or under the Uniform Federal Lien
4 Registration Act on or after July 9, 1988, naming a particular person
5 and, if a notice or certificate is on file, giving the date and hour of
6 filing of each notice or certificate. The fee for a certificate shall be
7 one dollar and fifty cents. Upon request the register of deeds shall
8 furnish a copy of any notice of federal lien or notice or certificate

11 ~~Secretary of State shall provide information as provided in section~~
12 ~~9-411, Uniform Commercial Code, and charge such fees provided in such~~
13 ~~section, on any notice of lien or certificate or notice affecting any~~
14 ~~lien filed under the Uniform Federal Lien Registration Act on or after~~
15 ~~July 1, 1999.~~

16 (b) Upon ~~(ii) On and after July 1, 2001, upon the request of any~~
17 person, the Secretary of State shall provide information as provided in
18 the Uniform Commercial Code and charge such fees provided in section
19 9-525, Uniform Commercial Code, on any notice of lien or certificate or
20 notice affecting any lien filed under the Uniform Federal Lien
21 Registration Act on or after July 1, 1999.

22 (4) The register of deeds and his or her employees or the Secretary
23 of State and his or her employees or agents shall be exempt from all
24 personal liability as a result of any error or omission in providing
25 information as required by this section except in cases of willful
26 misconduct or gross negligence.

27 **Sec. 4.** Section 52-1312, Reissue Revised Statutes of Nebraska, is
28 amended to read:

29 52-1312 The Secretary of State shall design and implement a central
30 filing system for effective financing statements. The Secretary of State
31 shall be the system operator. The system shall provide a means for filing

1 effective financing statements or notices of such financing statements on
2 a statewide basis. The system shall include requirements:

3 (1) That an effective financing statement or notice of such
4 financing statement shall be filed in the office of the Secretary of
5 State. A debtor's residence shall be presumed to be the residence shown
6 on the filing. The showing of an improper residence shall not affect the
7 validity of the filing. The filing officer shall mark the statement or
8 notice with a consecutive file number and with the date and hour of
9 filing and shall hold the statement or notice or a microfilm or other
10 digital copy thereof for public inspection. In addition, the filing
11 officer shall index the statements and notices according to the name of
12 the debtor and shall note in the index the file number and the address of
13 the debtor given in the statement;

14 (2) That the Secretary of State compile information from all
15 effective financing statements or notices filed with the Secretary of
16 State into a master list (a) organized according to farm product, (b)
17 arranged within each such product (i) in alphabetical order according to
18 the last name of the individual debtors or, in the case of debtors doing
19 business other than as individuals, the first word in the name of such
20 debtors, (ii) in numerical order according to the approved unique
21 identifier of the debtors, (iii) geographically by county, and (iv) by
22 crop year, and (c) containing the information referred to in subdivision
23 (4) of section 52-1307;

24 (3) That the Secretary of State cause the information on the master
25 list to be published in lists (a) by farm product arranged alphabetically
26 by debtor and (b) by farm product arranged numerically by the debtor's
27 approved unique identifier. If a registered buyer so requests, the list
28 or lists for such buyer may be limited to any county or group of counties
29 where the farm product is produced or located or to any crop year or
30 years or a combination of such identifiers;

31 (4) That all buyers of farm products, commission merchants, selling

1 agents, and other persons may register with the Secretary of State to
2 receive or obtain lists described in subdivision (3) of this section. Any
3 buyer of farm products, commission merchant, selling agent, or other
4 person conducting business from multiple locations shall be considered as
5 one entity. Such registration shall be on an annual basis. The Secretary
6 of State shall provide the form for registration which shall include the
7 name and address of the registrant and the list or lists described in
8 subdivision (3) of this section which such registrant desires to receive
9 or obtain. A registration shall not be completed until the form provided
10 is properly completed and received by the Secretary of State accompanied
11 by the proper registration fee set by the Secretary of State. ~~The fee for~~
12 ~~annual registration shall be thirty dollars.~~

13 ~~A registrant shall pay an additional annual fee to receive or obtain~~
14 ~~lists described in subdivision (3) of this section. For access to the~~
15 ~~master lien each farm product list which contains the lists described in~~
16 ~~subdivision (3) of this section, the registration fee shall be an amount~~
17 ~~determined by the Secretary of State not to exceed two hundred dollars~~
18 ~~per year.~~

19 The Secretary of State shall maintain a record of the registrants
20 and the lists and contents of the lists received or obtained by the
21 registrants for a period of five years;

22 (5) That the lists as identified pursuant to subdivision (4) of this
23 section be distributed or published by the Secretary of State not more
24 often than once every month and not less often than once every three
25 months as determined by the Secretary of State. The Secretary of State
26 may provide for the distribution or publication of the lists on any
27 medium and establish reasonable charges for such lists, not to exceed the
28 fee charges provided for in subdivision (4) of this section.

29 The Secretary of State shall, by rule and regulation, establish the
30 dates upon which the distributions or publications will be made, the
31 dates after which a filing of an effective financing statement will not

1 be reflected on the next distribution or publication of lists, and the
2 dates by which a registrant must complete a registration to receive or
3 obtain the next list; and

4 (6) That the Secretary of State remove lapsed and terminated
5 effective financing statements or notices of such financing statements
6 from the master list prior to preparation of the lists required to be
7 distributed or published by subdivision (5) of this section.

8 Effective financing statements or any amendments or continuations of
9 effective financing statements originally filed in the office of the
10 county clerk that have been indexed and entered on the Secretary of
11 State's central filing system need not be retained by the county filing
12 office and may be disposed of or destroyed.

13 The Secretary of State shall apply to the Secretary of the United
14 States Department of Agriculture for (a) certification of the central
15 filing system and (b) approval of the system or method of selecting an
16 approved unique identifier.

17 The Secretary of State shall remit any funds received pursuant to
18 subdivision (4) or (5) of this section to the State Treasurer for credit
19 to the Secretary of State Cash Fund.

20 **Sec. 5.** Section 52-1313, Reissue Revised Statutes of Nebraska, is
21 amended to read:

22 52-1313 (1) Presentation for filing of an effective financing
23 statement and the acceptance of the statement by the Secretary of State
24 constitutes filing under sections 52-1301 to 52-1322.

25 (2) The nonrefundable fee for presenting an effective financing
26 statement, an amendment, or a continuation statement for filing and
27 indexing and for stamping a copy furnished by the secured party to show
28 the date and place of filing of an effective financing statement, an
29 amendment, or a continuation statement shall be fourteen dollars if the
30 record is communicated in writing and eleven dollars if the record is
31 communicated by another medium authorized by the Secretary of State.

1 There shall be no fee for the filing of a termination statement.

2 (3) The Secretary of State shall remit any fees received pursuant to
3 this section to the State Treasurer for credit to the Secretary of State
4 Cash Fund.

5 **Sec. 6.** Section 52-1602, Reissue Revised Statutes of Nebraska, is
6 amended to read:

7 52-1602 (1) The master lien list prescribed in section 52-1601 shall
8 be distributed or published by the Secretary of State not more often than
9 once every month and not less often than once every three months on the
10 date corresponding to the date on which the lists provided pursuant to
11 sections 52-1301 to 52-1322 are distributed or published.

12 (2) Any person may register with the Secretary of State to receive
13 or obtain the master lien list prescribed in section 52-1601. Such
14 registration shall be on an annual basis. The Secretary of State shall
15 provide the form for registration. A registration shall not be completed
16 until the form provided is properly completed and received by the
17 Secretary of State accompanied by the proper registration fee set by the
18 Secretary of State. ~~The fee for annual registration shall be thirty~~
19 ~~dollars, except that a registrant under sections 52-1301 to 52-1322 shall~~
20 ~~not be required to pay the registration fee provided by this section in~~
21 ~~addition to the registration fee paid pursuant to sections 52-1301 to~~
22 ~~52-1322 for the same annual registration period. A registrant under~~
23 ~~sections 52-1601 to 52-1605 shall pay an additional annual fee to receive~~

6 to subsection (2) of this section to the State Treasurer for credit to
7 the Secretary of State Cash Fund.

9 2024, is amended to read:

10 77-3903 (1)(a) A notice of lien provided for in the Uniform State
11 Tax Lien Registration and Enforcement Act upon real property shall be
12 presented in the office of the Secretary of State. Such notice of lien
13 shall be provided ~~transmitted~~ by the Secretary of State to and filed in
14 the office of the register of deeds by the register of deeds of the
15 county or counties in which the real property subject to the lien is
16 situated as designated in the notice of lien. The register of deeds shall
17 enter the notice in the alphabetical state tax lien index, showing on one
18 line the name and residence of the person liable named in such notice,
19 the last four digits of the social security number or the federal tax
20 identification number of such person, the Tax Commissioner's or
21 Commissioner of Labor's serial number of such notice, the date and hour
22 of filing, and the amount due. Such presentments to the Secretary of
23 State may be made by direct input to the Secretary of State's database or
24 by other electronic means. All such notices of lien shall be retained in
25 numerical order in a file designated state tax lien notices, except that
26 in offices filing by the roll form of microfilm pursuant to section
27 23-1517.01, the original notices need not be retained. A lien subject to
28 this subsection shall be effective upon real property when filed by the
29 register of deeds as provided in this subsection.

30 (b) A notice of lien provided for in the Uniform State Tax Lien
31 Registration and Enforcement Act upon personal property shall be filed in

1 the office of the Secretary of State. The Secretary of State shall enter
2 the notice in the state's central tax lien index , ~~showing on one line~~
3 ~~the name and residence of the person liable named in such notice, the~~
4 ~~last four digits of the social security number or the federal tax~~
5 ~~identification number of such person, the Tax Commissioner's or~~
6 ~~Commissioner of Labor's serial number of such notice, the date and hour~~
7 ~~of filing, and the amount due.~~ Such filings with the Secretary of State
8 may be filed by direct input to the Secretary of State's database or by

11 (2) The uniform fee, payable to the Secretary of State, for
12 presenting for filing, releasing, continuing, or subordinating or for
13 filing, releasing, continuing, or subordinating each tax lien pursuant to
14 the Uniform State Tax Lien Registration and Enforcement Act shall be two
15 times the fee required for recording instruments with the register of
16 deeds as provided in section 33-109. There shall be no fee for the filing
17 of a termination statement. The uniform fee for each county more than one
18 designated pursuant to subdivision (1)(a) of this section shall be the
19 fee required for recording instruments with the register of deeds as
20 provided in section 33-109. The Secretary of State shall remit each fee
21 received pursuant to this subsection to the State Treasurer for credit to
22 the Secretary of State Cash Fund, except that of the fees received
23 pursuant to this subsection, the Secretary of State shall remit the fee
24 required for recording instruments with the register of deeds as provided
25 in section 33-109 to the register of deeds of a county for each
26 designation of such county in a filing pursuant to subdivision (1)(a) of

29 Commissioner of Labor on a monthly basis for fees for documents presented

2 Statutes of Nebraska, is amended to read:

3 9-523 Information from filing office; sale or license of records.

4 (a) If a person that files a written record requests an
5 acknowledgment of the filing, the filing office shall send to the person
6 an image of the record showing the number assigned to the record pursuant
7 to section 9-519(a)(1) and the date and time of the filing of the record.
8 However, if the person furnishes a copy of the record to the filing
9 office, the filing office may instead:

10 (1) note upon the copy the number assigned to the record pursuant to
11 section 9-519(a)(1) and the date and time of the filing of the record;
12 and

13 (2) send the copy to the person.

14 (b) If a person files a record other than a written record, the
15 filing office shall communicate to the person an acknowledgment that
16 provides:

17 (1) the information in the record;

18 (2) the number assigned to the record pursuant to section 9-519(a)
19 (1); and

20 (3) the date and time of the filing of the record.

21 (c) The filing office shall communicate or otherwise make available
22 in a record the following information to any person that requests it:

23 (1) whether there is on file on a date and time specified by the
24 filing office, but not a date earlier than three business days before the
25 filing office receives the request, any financing statement that:

26 (A) designates a particular debtor;

27 (B) has not lapsed under section 9-515 with respect to all secured
28 parties of record; and

29 (C) if the request so states, has lapsed under section 9-515 and a
30 record of which is maintained by the filing office under section
31 9-522(a);

- 1 (2) the date and time of filing of each financing statement; and
2 (3) the information provided in each financing statement.

3 (d) In complying with its duty under subsection (c), the filing
4 office may communicate information in any medium. However, if requested,
5 the filing office shall communicate information by issuing its written
6 certificate.

7 (e) The filing office shall perform the acts required by subsections
8 (a) through (d) at the time and in the manner prescribed by filing-office
9 rule, but not later than two business days after the filing office
10 receives the request.

11 (f) ~~(f)(1)~~ The Secretary of State shall offer to sell or license to
12 the public on a nonexclusive basis, in bulk, copies of all records filed
13 in the office of the Secretary of State under this part, in every medium
14 from time to time available to the filing office.

16 ~~part may be made available electronically through the portal established~~

28 indexing a record under this part is:

29 (1) Except as provided in subdivision (a)(3) of this section,
30 fourteen dollars if the record is communicated in writing;

31 (2) Except as provided in subdivision (a)(3) of this section, eleven

1 dollars if the record is communicated by another medium authorized by
2 filing-office rule; and

3 (3) One hundred dollars if the debtor is a transmitting utility and
4 the filing so indicates.

5 (b) The number of names required to be indexed does not affect the
6 amount of the fee in subsection (a).

7 (c) There is no fee for the filing of a termination statement.

8 (d)(1) The fee for responding to a request for information from the
9 filing office, including for communicating whether there is on file any
10 financing statement naming a particular debtor, is five dollars if the
11 request is communicated in writing.

12 (2) The fee for responding to a request for information from the
13 filing office, including for communicating whether there is on file any
14 financing statement naming a particular debtor, is four dollars and fifty
15 cents if the request is communicated by another medium authorized by
16 filing-office rule.

17 ~~(e) The fees charged by county clerks for inquiries and other~~
18 ~~services regarding information in the centralized computer system shall~~

20 ~~(e) (f)~~ The Secretary of State shall remit the fees received by the
21 Secretary of State pursuant to this section to the State Treasurer for
