- 1 A BILL FOR AN ACT relating to license plates; to amend sections 60-3,113
- and 60-3,122.04, Reissue Revised Statutes of Nebraska, and sections
- 3 60-3,122.03, 60-3,123, 60-3,124, and 60-3,125, Revised Statutes
- 4 Cumulative Supplement, 2024; to change and provide provisions
- 5 relating to Military Honor Plates, prisoner-of-war license plates,
- 6 disabled veteran license plates, and Purple Heart license plates; to
- 7 provide duties to the Department of Motor Vehicles; to harmonize
- 8 provisions; and to repeal the original sections.
- 9 Be it enacted by the people of the State of Nebraska,

- **Section 1.** Section 60-3,113, Reissue Revised Statutes of Nebraska,
- 2 is amended to read:
- 3 60-3,113 (1) The department shall, without the payment of any fee
- 4 except the taxes and fees required by sections 60-3,102, 60-3,185,
- 5 60-3,190, and 60-3,191, issue license plates for one motor vehicle not
- 6 used for hire and a license plate for one autocycle or motorcycle not
- 7 used for hire to:
- 8 (a) Any permanently handicapped or disabled person or his or her
- 9 parent, legal guardian, foster parent, or agent upon application and
- 10 proof of a permanent handicap or disability; or
- 11 (b) A trust <u>that</u> which owns the motor vehicle, autocycle, or
- 12 motorcycle if a designated beneficiary of the trust qualifies under
- 13 subdivision (a) of this subsection.
- 14 (2) An application and proof of disability in the form and with the
- 15 information required by section 60-3,113.02 shall be submitted before
- 16 <u>such</u> license plates are issued or reissued.
- 17 (3) (2) The license plate or plates shall carry the internationally
- 18 accepted wheelchair symbol, which symbol is a representation of a person
- 19 seated in a wheelchair surrounded by a border six units wide by seven
- 20 units high, and such other letters or numbers as the director prescribes.
- 21 Such license plate or plates shall be used by such person in lieu of any
- 22 <u>other the usual</u> license plate or plates.
- (4) (3) The department shall compile and maintain a registry of the
- 24 names, addresses, and license numbers of all persons who obtain <u>license</u>
- 25 plates with the internationally accepted wheelchair symbol pursuant to
- 26 this section and sections 60-3,122.03, 60-3,122.04, 60-3,124, and
- 27 <u>60-3,125</u> special license plates pursuant to this section and all persons
- 28 who obtain a handicapped or disabled parking permit.
- Sec. 2. Section 60-3,122.03, Revised Statutes Cumulative Supplement,
- 30 2024, is amended to read:
- 31 60-3,122.03 (1) The department shall design license plates to be

- 1 known as Military Honor Plates.
- 2 (2)(a) (2) The department shall create designs honoring persons who
- 3 have served or are serving in the United States Army, United States Army
- 4 Reserve, United States Navy, United States Navy Reserve, United States
- 5 Marine Corps, United States Marine Corps Reserve, United States Coast
- 6 Guard, United States Coast Guard Reserve, United States Air Force, United
- 7 States Air Force Reserve, <u>United States Space Force</u>, Air National Guard,
- 8 or Army National Guard.
- 9 <u>(b) The department may begin issuing the license plates with the</u>
- 10 <u>design honoring persons who have served or are serving in the United</u>
- 11 States Space Force on January 1, 2026.
- 12 (3) There shall be <u>thirteen</u> twelve such designs, one for each of
- 13 such armed forces reflecting its official emblem, official seal, or other
- 14 official image. The issuance of plates for each of such armed forces
- 15 shall be conditioned on the approval of the armed forces owning the
- 16 copyright to the official emblem, official seal, or other official image.
- 17 (4) The department shall create six five additional designs honoring
- 18 persons who are serving or have served in the armed forces of the United
- 19 States and who have been awarded the Afghanistan Campaign Medal, Iraq
- 20 Campaign Medal, Global War on Terrorism Expeditionary Medal, Southwest
- 21 Asia Service Medal, or Vietnam Service Medal, or Inherent Resolve
- 22 Campaign Medal.
- 23 (5) The department shall create the following additional designs
- 24 honoring persons who are serving or have served in the armed forces of
- 25 the United States and may begin issuing such license plates on January 1,
- 26 2026:
- 27 <u>(a) One design that includes the word "veteran"; and</u>
- 28 <u>(b) One design that includes the word "veteran" and the</u>
- 29 <u>internationally accepted wheelchair symbol specified in section 60-3,113.</u>
- 30 (6)(a) (5) A person may qualify for a Military Honor Plate by
- 31 registering with the Department of Veterans' Affairs pursuant to section

- 1 80-414. The Department of Motor Vehicles shall verify the applicant's
- 2 eligibility for a plate created pursuant to this section by consulting
- 3 the registry established by the Department of Veterans' Affairs.
- 4 (b) To be eligible for the license plates described in subdivision
- 5 (5)(b) of this section, in addition to any other eligibility requirements
- 6 for such license plates under this section:
- 7 (i) An application and proof of disability in the form and with the
- 8 information required by section 60-3,113.02 shall be submitted before
- 9 <u>issuance or reissuance of such license plates; and</u>
- 10 (ii) The handicap or disability of the handicapped or disabled
- 11 person shall be certified as permanent.
- 12 (7) (6) The design shall be selected on the basis of limiting the
- 13 manufacturing cost of each plate to an amount less than or equal to the
- 14 amount charged for license plates pursuant to section 60-3,102. The
- 15 Department of Motor Vehicles shall make applications available for each
- 16 type of plate when it is designed. The department may adopt and
- 17 promulgate rules and regulations to carry out this section and section
- 18 60-3,122.04.
- 19 (8) (7) One type of Military Honor Plates shall be alphanumeric
- 20 plates. The department shall:
- 21 (a) Assign a designation up to five characters; and
- 22 (b) Not use a county designation.
- 23 (9) (8) One type of Military Honor Plates shall be personalized
- 24 message plates. Such plates shall be issued subject to the same
- 25 conditions specified for personalized message license plates in section
- 26 60-3,118, except that a maximum of five characters may be used.
- 27 (10) (9) The department shall cease to issue Military Honor Plates
- 28 beginning with the next license plate issuance cycle after the license
- 29 plate issuance cycle that begins in 2023 pursuant to section 60-3,101 if
- 30 the total number of registered vehicles that obtained such plates is less
- 31 than one five hundred per year within any prior consecutive two-year

- 30 United States Public Health Service, or a report of transfer or discharge
- 31 provided by the National Oceanic and Atmospheric Administration;

- 2 forces of the United States and who has been awarded the Afghanistan
- 3 Campaign Medal, Iraq Campaign Medal, Global War on Terrorism

- 5 Medal; -
- 6 (iv) For the license plate described in subdivision (5)(a) of
- 7 <u>section 60-3,122.03</u>, a person who is serving or has served in the armed
- 8 forces of the United States;
- 9 (v) For the license plate described in subdivision (5)(b) of section
- 10 60-3,122.03, a person who is serving or has served in the armed forces of
- 11 the United States and is permanently handicapped or disabled; or
- (vi) Beginning January 1, 2026, a trust that owns the motor vehicle,
- 13 <u>trailer</u>, or <u>semitrailer</u> if a <u>designated</u> <u>beneficiary</u> of the <u>trust</u>
- 14 qualifies under subdivision (1)(c) of this section.
- 15 <u>(d)</u> Any person using Military Honor Plates shall surrender the
- 16 plates to the county treasurer if such person is no longer eligible for
- 17 the plates. Regular plates shall be issued to any such person upon
- 18 surrender of the Military Honor Plates for a three-dollar transfer fee
- 19 and forfeiture of any of the remaining annual fee. The three-dollar
- 20 transfer fee shall be remitted to the State Treasurer for credit to the
- 21 Department of Motor Vehicles Cash Fund.
- 22 (2)(a) In addition to all other fees required for registration under
- 23 the Motor Vehicle Registration Act, each application for initial issuance
- 24 or renewal of alphanumeric Military Honor Plates shall be accompanied by
- 25 a fee of five dollars. County treasurers collecting fees pursuant to this
- 26 subdivision shall remit them to the State Treasurer. The State Treasurer
- 27 shall credit five dollars of the fee to the Nebraska Veteran Cemetery

If Beginning on an 12 13 implementation date designated by the director on or before January 1, 14 2022, if delivery of the plates and registration certificate is made by the department to the applicant, the department may charge a postage and 15 16 handling fee in an amount not more than necessary to recover the cost of postage and handling for the specific items mailed to the registrant. The 17 department shall remit the fee to the State Treasurer for credit to the 18 Department of Motor Vehicles Cash Fund. The county treasurer or the 19 department shall issue Military Honor Plates in lieu of regular license 20 plates when the applicant complies with the other provisions of the Motor 21 Vehicle Registration Act for registration of the motor vehicle or 22 23 trailer. If Military Honor Plates are lost, stolen, or mutilated, the 24 licensee shall be issued replacement license plates upon request pursuant 25 to section 60-3,157.
- (b) The county treasurer or the department may issue temporary license stickers to the applicant under this section for the applicant to lawfully operate the vehicle pending receipt of the license plates. No charge in addition to the registration fee shall be made for the issuance of a temporary license sticker under this subdivision. The department shall furnish temporary license stickers for issuance by the county

- 1 treasurer at no cost to the counties. The department may adopt and
- 2 promulgate rules and regulations regarding the design and issuance of
- 3 temporary license stickers.
- 4 (4) The owner of a motor vehicle or trailer bearing Military Honor
- 5 Plates may apply to the county treasurer to have such plates transferred
- 6 to a motor vehicle or trailer other than the motor vehicle or trailer for
- 7 which such plates were originally purchased if such motor vehicle or
- 8 trailer is owned by the owner of the plates. The owner may have the
- 9 unused portion of the fee for the plates credited to the other motor
- 10 vehicle or trailer which will bear the plates at the rate of eight and
- 11 one-third percent per month for each full month left in the registration
- 12 period. Application for such transfer shall be accompanied by a fee of
- 13 three dollars. Fees collected pursuant to this subsection shall be
- 14 remitted to the State Treasurer for credit to the Department of Motor
- 15 Vehicles Cash Fund.
- 16 (5) If the cost of manufacturing Military Honor Plates at any time
- 17 exceeds the amount charged for license plates pursuant to section
- 18 60-3,102, any money to be credited to the Nebraska Veteran Cemetery
- 19 System Operation Fund shall instead be credited first to the Highway
- 20 Trust Fund in an amount equal to the difference between the manufacturing
- 21 costs of Military Honor Plates and the amount charged pursuant to section
